#### **20200604-EC-01**

The Executive Committee decided to appoint Prof. Miran Kondric as Medical Officer for Tokyo 2020 Olympic Games.

**20200604-EC-04**

The Executive Committee decided to give the mandate to the ITTF lawyer, Mr Antonio Rigozzi, to continue the attempts to find a settlement as per the instructions and conditions set by the ITTF.

**20200604-EC-05**

The Executive Committee ratified the adjustments made on the qualification system for Tokyo 2020 Olympic Games, pending on the ratification of the IOC.

**20200604-EC-06**

The Executive Committee ratified the adjustments made on the qualification system for Tokyo 2020 Paralympic Games, which are already pre-approved by the IPC.

**20200604-EC-07**

The Executive Committee through the ITTF Foundation, and together with World Table Tennis (WTT), decided to approve the TT United fund to provide financial support for National Associations, Players and Foundation projects affected by the COVID-19 crisis.

**20200604-EC-08**

The Executive Committee agreed to make a public statement underlining ITTF's zero-tolerance against any form of discrimination.
