### ANNUAL GENERAL MEETING

**MINUTES** of the Annual General Meeting of the International Table Tennis Federation held in a hybrid format on Tuesday, 6<sup>th</sup> December 2022, at 10h00 Eastern European Summer Time, in the Royal Culture Centre, Queen Aliaa Street 31, Amman, Jordan.

#### 1. <u>President's Welcome and Opening Address</u>

The **President**, Ms Petra SÖRLING, welcomed the Delegates to the AGM, particularly the new Co-Chairs of the Athletes Commission, Ms LIU Shiwen and Mr Sharath Kamal ACHANTA, highlighting the fact of having a second female representative in the Executive Committee (**EC**) for the first time since 2009. The **President** spoke about the visits to the different major continental events and congresses where the common denominator was the passion she could feel within the ITTF family.

The **President** praised the successful organisation of the World Table Tennis Championships Finals in Chengdu, the only international event held in 2022 China besides the Beijing Olympic and Paralympic Games. The **President** congratulated the ITTF Deputy President and Chinese Table Tennis Association (**CTTA**) President, Mr LIU Guoliang, CTTA staff and volunteers for making it possible.

The **President** also congratulated the Royal Spanish Table Tennis Federation for successfully organising the World Para Table Tennis Championships in Granada, Spain. An event that did set the standards for Para events for the future, raising the standards in both sports' presentation and sustainability.

The **President** reflected on her recent appointments to the IOC Gender Equality, Diversity and Inclusion Commission, WADA Foundation Board, and IMGA Executive Board, not only as an honour but also as a sign of how table tennis is growing and becoming more recognised, is playing a more important role in the world of sports.

To conclude, the **President** thanked the Membership for believing in her, the **EC**, the ITTF, the ITTF Foundation, and World Table Tennis, thanked HRH Prince Feisal bin HUSSEIN for his warm welcome to Jordan and his motivation to highlight the important area of safeguarding, and thanked the Jordan Table Tennis Federation (**JTTF**) for hosting the Summit, and the Qatar Table Tennis Association (**QTTA**) for their support to the host, declaring the AGM Open.

#### 2. Host Welcome and Opening Address

HRH Prince Feisal bin HUSSEIN, President of the Jordan Olympic Committee (**JOC**) and IOC Member, addressed the AGM through a video-recorded message, being on this day in Lausanne, Switzerland, due to IOC meetings. HRH Prince Feisal thanked the EC for the invitation to their meeting on 3<sup>rd</sup> December and congratulated the ITTF for the successful organisation of the WTTC Finals in Chengdu.

HRH Prince Feisal took the opportunity to address the Delegates on the importance of safeguarding and prevention of abuse in sport, highlighting the message he shared at the 8th International Working Group (IWG) World Conference on Women and Sport in this respect, on his capacity as Chair of the IOC Prevention of Harassment of Abuse in Sport Working Group. HRH Prince Feisal stressed the need for the National Olympic Committees (**NOCs**) and International Federations (**IFs**) to provide an environment that is fair, equitable and free from all forms of harassment for its athletes.

HRH Prince Faisal mentioned the IOC athletes safeguarding toolkit for IFs and NOCs launched in 2017 and the extensive survey conducted by the IOC to identify the status of the world of sports in this important area.

To conclude, HRH Prince Feisal reflected on Amman becoming a focal point of table tennis events, hoping to welcome many more in the future, and wishing all delegates a very productive meeting and enjoyable time in Amman.

Mr Nasser MAJALI, Secretary General of the JOC, also welcomed the Delegates to Amman, Jordan, on behalf of HRH Price Feisal, the JOC, and the JTTF. Mr MAJALI thanked the ITTF representatives for their support in bringing the Summit to Jordan, hoping to respond to the challenge by hosting it in a way that all participants are pleased with the experience.

Mr MAJALI highlighted the important messages the Summit has emphasised, such as sustainable development programmes, the crucial safeguarding programme, and the continued pursuit of global gender equity and gender justice, encouraging the Member Associations to benefit from the IOC Toolkit for IFs and NOCs on Safeguarding athletes from harassment and abuse in sport.

To conclude, Mr MAJALI wished for the delegates to be able to visit the Jordanian Capital, Amman, and the historic city of Petra, hoping to welcome the delegates once again in the near future.

#### 3. Roll Call of Associations Present (Confirmation of registered Associations)

The Secretary General proceeded with the Roll Call of <u>registered associations</u>, and the coffee break was brought forward in view of the technical problems <sup>1</sup>.

Following the Roll Call, the Secretary General presented the two options to carry on with the voting of the different items on the agenda depending on the Internet situation. The proposal from QTTA and Bahrain Table Tennis Association (**BTTA**) to vote manually was noted.

4. Confirmation of the Agenda

The Agenda was confirmed by a show of hands.

#### 5. Appointment of a Chair

Ms Petra SÖRLING, ITTF President, was nominated by the EC to be the Chair of the AGM.

#### 2022-12-06-AGM-01 (simple majority required)

The AGM accepted the nomination of Ms Petra SÖRLING as AGM Chair by acclamation.

#### 6. Appointment of Scrutineers

The AGM noted that due to the hybrid nature of the meeting, LUMI ® company would be conducting the voting, with Mr Ben RILEY and Kyle SLEEP as operators of the technological solution. The AGM noted that LUMI operations would be supervised by Mr Edward GARDINER, a public notary from Cheeswrights.

#### 2022-12-06-AGM-02 (simple majority required)

The AGM appointed the scrutineers nominated by the Continental Presidents by acclamation.

#### 7. Confirmation of the Minutes of the AGM held on 24<sup>th</sup> November 2021 in Houston, USA.

Mr AL-MOHANNADI asked the AGM to update the 2021 AGM Minutes to reflect the fact that following the EC decision on 18<sup>th</sup> November 2021 to cancel the AGM and the elections in Houston, they were held only because of his personal decision and to clarify that the VISA of Mr AL-MOHANNADI was not granted but not for the reasons Mr WEIKERT stated during the Houston meeting, adding that this was put in the hands of the ITTF Integrity Unit.

The Secretary General also mentioned the feedback from St. Lucia's delegate, Mr Teddy MATTHEWS, about adding the first names of Mr Khalil AL-MOHANNADI and Mr Nestor TENCA in their first mentions in the Minutes.

The delegate of Iraq, Mr Emad HUSSAIN, suggested that Mr WEIKERT misled the AGM in 2021 when indicating the reasons why Mr AL-MOHANNADI did not receive his VISA, and requested an apology from Mr WEIKERT for that, highlighting that the Chair of an AGM has to tell the truth to the Members at all times, and should allow the Members to speak.

The **President** thanked Mr HUSSAIN for his contribution, indicating that those statements of the 2021 AGM are in the hands of the Integrity Unit for their evaluation, as agreed with Mr AL-MOHANNADI.

The delegate of Bahrain, Mr Ali ALMADEH requested the AGM to ensure future events are awarded to countries ensuring VISAS for all participants.

Mr AL-MOHANNADI asked the AGM delegates to stop the comments on his case, as the matter has been put in the hands of the Integrity Unit.

Following the comments received, the AGM approved the Minutes, with the two amendments proposed.

2022-12-06-AGM-03 (simple majority required)

The AGM adopted the <u>2021 AGM Minutes</u><sup>2</sup> as a true record by acclamation.

#### 8. <u>Membership</u>

The **AGM** noted that there are no new applications for membership. The **President** indicated that one of the upcoming tasks is to ensure the activation of the 227 Members, as highlighted in different moments of the Summit.

The Secretary General indicated that the matter affecting the Table Tennis Federation of India (**TTFI**) will be dealt with in the section of Propositions and Resolutions.

#### 9. <u>Recognitions</u>

- 9.1 The **President** asked for a minute of silence in memoriam of the Table Tennis colleagues deceased since the last AGM. A commemorative video was presented.
- 9.2 QTTA. WTT Middle East Hub

ITTF Executive Vice President, Mr Graham SYMONS, presented to Mr Abdulla AL MULLA, representing QTTA, a plaque in appreciation for hosting the 2022 Middle East Hub in Qatar.

9.3 Japan Table Tennis Association (JTTA). Tokyo 2020 Olympic and Paralympic Games

The IOC Member, Mr RYU Seungmin, presented to Ms Sachiko YOKOTA, representing JTTA, a plaque appreciation for the support given by JTTA to the Tokyo Olympic and Paralympic Games Organising Committee (**TOGOC**) and the ITTF in the organisation of the Tokyo 2020 Olympic and Paralympic Games.

9.4 USA Table Tennis (USATT). Houston 2021 World Table Tennis Championships Finals

ITTF Executive Vice President, Mr Alaor AZEVEDO, presented to Ms Virginia SUNG, representative of USATT, a plaque in appreciation for the organisation of the Houston 2021 WTTC Finals.

9.5 Portuguese Table Tennis Association (**FPTM**). Vila Nova de Gaia 2021 World Youth Table Tennis Championships

ITTF Executive Vice President, Mr Roland NATRAN, presented to Mr Luis GARRETT, representing FPTM, a plaque in appreciation for the organisation of the Vila Nova de Gaia 2021 WYTTC.

9.6 Singapore Table Tennis Association (STTA). Singapore 2021 WTT Cup Finals

ITTF Executive Committee Member, and Co-Chair of the ITTF Athletes Commission, Mr Sharath Kamal ACHANTA, presented the plaque to STTA (attending online) in appreciation for the support given in the organisation of the Singapore 2021 WTT Cup Finals.

9.7 JTTF. First ITTF Summit

ITTF Executive Vice President, Dr Alaa MESHREF, presented the plaque to Mr Ibrahim ALSARAYREH, representative of JTTF, in appreciation for the organisation of the first-ever ITTF Summit.

10. Annual General Report & Strategic Plan (SP)

The AGM noted the update from Mr Steve DAINTON, ITTF Group CEO (**CEO**), on the progress made in the five existing pillars of the current SP.

The **President** updated the AGM on the plans to review the SP, which will include a consultation process with the membership, and would like to focus on three areas, namely Governance and Sustainability, Society and Health, and Business Growth.

The **CEO** abounded on the three pillars and the key areas of work in each of them, explaining the plans to discuss them over the coming months, reaching out to all stakeholders and hoping to have, by the end of May, a draft which would be eventually adopted at the 2023 AGM.

- 11. Presentations
- 11.1 ITTF Group CEO

The AGM noted the video report of the CEO on the 2021 activities, which highlighted the formal launch of WTT events, thanking Mr AL-MOHANNADI and Qatar for their support in such a difficult period; the successful Olympic and Paralympic Games Tokyo 2020; the WTT Cup Finals in Singapore; the World Youth Championships in Vila Nova de Gaia, Portugal; and giving special emphasis to the WTTC Finals held in Houston, which was particularly important after the cancellation of the 2020 World Championships.

The AGM also noted the report of the progress in governance, member relations, and development, with record numbers of online training and activities. The CEO also touched on the ITTF Foundation activities and the successful hosting of the ITTF AGM in Houston, where elections were held, thanking the leadership of the new EC members, the **President**, and the outgoing EC members, which term finished in 2021.

The CEO also reported on the 2022 activities, a year which was supposed to be one of return to normality, but new COVID-19 variants and another war hit the world. Nevertheless, compared to 2021, more activities could be organised, with the pinnacle being the WTTC Finals held in Chengdu in October, followed by the WTT Champions event in Macao, and the WTT Cup Finals in Xinxiang, China. The CEO highlighted these being the only international events held in China in 2022 besides the Olympic and Paralympic Games, and thanked the ITTF Deputy President and Chair of the WTT Board, Mr LIU Guoliang, and the entire CTTA team for making it possible.

The CEO also spoke about the over 100 events held in the different categories, highlighting the best-ever presented and organised World Para Table Tennis Championships in Granada, Spain.

The CEO continued reporting on the World Table Tennis day, with over 300 activities made around the world on 6<sup>th</sup> April 2022, over 80 field projects carried in Development, and over 100 national projects supported.

The CEO concluded by announcing record revenues in 2022 of 35 million dollars which will be presented in the Finance section, and speaking about 2023 expectations: an event's calendar with a record number of events, the new SP, rebranding and restructuring of the ITTF development, further financial growth, fantastic WTTC Finals in Durban, South Africa, at least two WTT Grand Smashes, a full year calendar, rebranding of veterans' events, TTX return, another Summit, making sustainability part of all ITTF Group programmes, more ITTF Foundation activities, more projects for ITTF MAs, and more synergies with the Continental Federations, just to mention a few, and thanked the AGM for their attention.

#### 11.2 Other presentations

#### 11.2.1 ITTF Foundation

The AGM noted the update from Mr Leandro OLVECH on the ITTF Foundation, with the new vision: "Table Tennis. For All. For a Better Life.", the new dates for the World Table Tennis Day (WTTD) from 2023 onwards (23<sup>rd</sup> April) coinciding with the date of birth of Igor MONTAGU, the first ITTF President, and the topic for the WTTD 2023: "Think Sustainably, Act Now!".

Mr OLVECH also spoke about introducing the World Table Tennis for Health Festival, for which the first edition will be held in November 2023, including activities for players affected by Parkinson, but also for those affected by Alzheimer, and about the Dream Building Fund.

The AGM noted the video presentation on the activities carried out by the ITTF Foundation in 2021.

Mr OLVECH thanked the ITTF Foundation staff, the Governing Board members, particularly HRH Zeina RASHED, from Jordan, for her support in hosting the Corporate Cup in Amman, and Mr Steve DAINTON, being the main donor to the foundation in 2021.

#### 11.3 World Table Tennis

The AGM noted the presentation by Mr Matt POUND on WTT, the for-profit company created by the ITTF in 2019 to run all the ITTF events and commercial business.

Mr POUND reported on the recently signed minority equity agreement with World Sports, the first-ever investor in WTT with whom Mr POUND expects to work to be able to grow the WTT business together.

The AGM was updated on the difficulties faced due to the pandemic, which slowed down the initial stages of growth, expecting, however, to have a full calendar of events by 2024.

Mr POUND thanked the full support of the WTT Board and presented the major events hosted since the launch in Macao in December 2020, reflecting on the fact that all tiers of events in the new structure have now been delivered.

The AGM noted the excellent figures of the first-ever Grand Smash held in Singapore in March 2022, the new WTT website and App, the growth in social media, and the global premium partners signed.

To conclude his presentation, Mr POUND abounded on the key aspects of attention for the future: full calendar by 2024, digital transformation continuation, further financial investment, and sustainable events worldwide.

Mr AL-MOHANNADI encouraged the AGM delegates to host events in their respective countries.

Mr Robert JJAGWE, delegate of Uganda, and Mr George KOPALY, delegate of Lebanon and BoD member, spoke about the cost of hosting WTT events, and the **CEO** encouraged them to discuss with the WTT staff to ensure common understanding, as the key is the will to host events, and other aspects should be second to that intention.

Ms Claude BERGERET, BoD member, expressed her concern about the calendar having enough free dates for the national and continental competitions, and the **CEO** suggested the most important is to ensure having a stable calendar that will allow all stakeholders to plan accordingly.

#### 12. Finance

The **President** introduced Mr Roland NATRAN, ITTF Executive Vice President of Finance, and Mr Michael BROWN, ITTF Group CFO, to present this section of the Agenda.

#### 12.1 <u>Report of the Finance and Audit Committee</u>

Mr NATRAN presented the report of the Finance and Audit Committee (**FAC**) on the approval of the Financial Statements of the ITTF and ITTF Group, and the bidding process for the 2023 auditors' selection. New methodologies were discussed to ensure a comprehensive, transparent, and prudent presentation of the ITTF Finances.

Mr NATRAN thanked Mr Michael BROWN, ITTF Group CFO, and his team, for the work done in this process. The AGM noted the intention to move into International Financial Reporting Standards (**IFRS**) in the future and the plans to manage risk within the organisation.

#### 12.2 Financial Report

Mr NATRAN commented on the fact that the recovery of the ITTF finances in 2021 and 2022 show that the ITTF is on the right track of a revolutionary change in the way the ITTF Group operates its events structure, describing it as a period of investment.

#### 12.3 2021 Audited Financial Statements (AFS)

The AGM noted the 2021 AFS, as presented by Mr BROWN, which showed two major investments, in the commencement of WTT, and in the World Table Tennis Championships Finals, to ensure they were held in 2021 after being cancelled in 2020.

Mr BROWN explained the 2021 Financial Position, Income, Expenses, and Net Balance History in the period 2017-2021.

Mr Michael ACKERMANN, Executive in Charge of MAZARS SA (the ITTF Auditing Firm for the year 2021), indicated that the AFS were elaborated accorded to Swiss Auditing Standards. Mr ACKERMANN declared that the financial statements for 2021 comply with Swiss Law and confirmed that an internal control system exists, recommending to the AGM to approve the AFS submitted.

#### 12.4 2022 Updated Budget

Mr BROWN presented the 2022 updated budget, which foresees a record income level for the ITTF Group exceeding 35 million USD. The AGM noted that the expenses will also be increased, and Mr BROWN added that this is part of the long-term growth strategy.

#### 12.5 2021-2024 Quadrennial Forecast

Mr BROWN presented an overview of the 2021-2024 Quadrennial Forecast, which shows the net balances becoming less negative year by year within 2021-2024, expecting those net balances to become positive in the cycle 2025-2028.

The AGM noted the expected significant growth in 2023 and 2024 and a summary of the changes introduced during this quadrennial, which had the revamping of the events' structure events and the COVID-19 pandemic as the two most significant factors.

Mr BROWN suggested the WTTTC Finals held in Chengdu recently provide optimism for a greater calendar in 2023, with approximately 75% of events being confirmed, hoping to have a full calendar by 2024.

#### 12.6 Appointment of 2022 and 2023 auditors.

Mr BROWN reported on the recommendation to retain Mazars as the auditing firm for 2022, and to appoint PricewaterhouseCoopers (PwC) for 2023 as the result of the audit tender process carried out over the last few months, as recommended by the FAC to the ITTF.

The Secretary General explained that electronic voting will be disabled for the voting delegates physically present in the room in Amman. The voting for the different motions will be made by a show of hands for those in the room and by electronic voting via LUMI for those attending remotely, adding both results to confirm the outcome of each motion.

#### 2022-12-06-AGM-04 (simple majority required)

The AGM approved the Financial Statements for 2021.

84 valid votes. 84 votes in favour. 0 votes against. 100% in favour (1 abstention).

#### 2022-12-06-AGM-05 (simple majority required)

The AGM accepted the 2022 updated budget.

84 valid votes. 84 votes in favour. 0 votes against. 100% in favour (2 abstentions).

#### 2022-12-06-AGM-06 (simple majority required)

The AGM accepted the 2021-2024 updated quadrennial forecast.

86 valid votes. 85 votes in favour. 1 vote against. 98.84% in favour (3 abstentions).

#### 2022-12-06-AGM-07 (simple majority required)

The AGM agreed to retain Mazars as Auditor for 2022.

80 valid votes. 80 votes in favour. 0 votes against. 100 % in favour (1 abstention).

#### 2022-12-06-AGM-08 (simple majority required)

The AGM agreed to appoint PricewaterhouseCoopers (PwC) as Auditor for 2023.

76 valid votes. 75 votes in favour. 1 vote against. 98.68 % in favour (1 abstention).

The President thanked Mr Michael ACKERMANN for his work, first at Ernst & Young and later at Mazars, by carrying out the audits for the ITTF in the last couple of years.

The **President** also thanked Mr NATRAN and Mr BROWN for the work done in the area of Finances.

Mr Abdulla AL MULLA, BoD member and acting chair of the Nominations Committee (NC), thanked the ITTF Secretary General for his annual report and asked whether the decision

of Mr WEIKERT to dismiss Mr AL-MOHANNADI from the position of Deputy President, later restored on the position by the EC, was cleared or not and whether Mr WEIKERT had the right to do so. Mr AL MULLA also asked the AGM delegates whether it is normal that a President who is honoured by the AGM delegates by awarding him the title of Honorary President deserves such a title when he takes his EC colleagues to the ITTF Tribunal, provoking the high legal expenses the ITTF incurred on to defend its (EC) members.

The Secretary General responded, assuming Mr AL MULLA's question was half rhetorical, indicating that the situations that occurred due to Mr WEIKERT's actions were carefully analysed. Some reforms in the ITTF Constitution were already proposed to the AGM in Houston, and further reforms are being proposed at this AGM in Amman to ensure that similar situations do not happen again in the future.

15.3 ITTF Continental Council

15.4 ITTF Integrity Unit

Mr CARPENTER added to the Integrity Unit report his wish to put on record the appreciation to the ITTF Group Head of Legal and Corporate Affairs, Dylan MAH, who acted as ITTF Integrity Officer until Mr CARPENTER took over on 4<sup>th</sup> October 2021, and provided a further update in work being carried by the Integrity Unit in cases of match manipulation.

On a question from Mr Emad HUSSAIN, delegate of Iraq, Mr CARPENTER confirmed that, at present, he is the only staff of the Integrity Unit. However, discussions are being held with the ITTF to enlarge the Unit's capacity. Mr CARPENTER also explained that the Integrity Unit reports to the Integrity Board. Mr HUSSAIN abounded on how the Unit could operate with such limited resources, and Mr CARPENTER confirmed the ongoing discussions to ensure more capacity in terms of both financial and human resources. Mr HUSSAIN suggested that to ensure proper operations of the Unit, more support is required.

The **President** indicated that as the ITTF grows, certainly more work will need to be done in this area, particularly in education, ensuring a proactive approach. The **President** passed the word to the CEO, who, in turn, indicated that there are current discussions to ensure an independent budget is made available for the Integrity Unit, hoping to achieve it by 2023.

Mr MUDIBO asked Mr CARPENTER how long a case can take to be cleared when addressed to the Integrity Unit and whether the outcome of the investigations of the Integrity Unit will be made available through the ITTF website. To the first question, Mr CARPENTER responded that it would depend on its nature, in the necessity or not to have a number of witnesses, but in general, it can be a matter of months. To the second question, Mr CARPENTER indicated that also, depending on the nature of the case, it may be that the reports are made via direct communication to the Member Associations and/or via publication on the ITTF website, depending on the nature of the offences.

#### 17. Ratification of the Work Done by the Board of Directors (BoD) and the Executive Committee

#### 2022-12-06-AGM-09 (simple majority required)

The AGM ratified the work done by the Board of Directors and the Executive Committee since the last Annual General Meeting.

82 valid votes. 82 votes in favour. 0 votes against. 100 % in favour (2 abstentions).

The **President** thanked the Delegates for the ratification and moved to the next point on the agenda.

#### 18. Governance Review Report

The **President** invited Mr Wahid Enitan OSHODI, Executive Vice President in charge of Governance, to report on the work being done by the Governance Review World Group (**GRWG**). Mr OSHODI commented on the holistic review of the ITTF Handbook being made by the GRWG, particularly after the creation of the ITTF Foundation in 2018 and World Table Tennis in 2019. The AGM noted that some of the propositions presented at this AGM are the result of the work being made by the GRWG. However, Mr OSHODI added that the GRWG needs further work to align with the standards and recommendations set by the IOC and the ASOIF.

Mr OSHODI invited Mr RIPOLL, Chair of the ITTF Integrity Board, to comment further on the propositions submitted to this AGM. Mr RIPOLL expressed his satisfaction with the commitment shown by the ITTF family during these days to the areas of integrity, transparency, equality, and safeguarding. Mr RIPOLL suggested that any further steps, even small, are important towards the overall goal of accomplishing the highest levels of good governance of the ITTF, adding that in present times, the reputation of sports is paramount for their existence.

#### 19. Propositions and Resolutions

The AGM considered the following propositions <sup>6</sup>, which required a **2/3 majority** of the votes cast:

79 valid votes. 78 votes in favour. 1 vote against. 98.73 % in favour (1 abstention).

The proposition was **PASSED**.

2022-12-06-AGM-12 (2/3 majority required)

Proposition A-05. Presented by the Member Association of HKG (click here for details)

64 valid votes. 19 votes in favour. 45 votes against. 29.69 % in favour (7 abstentions).

The proposition was **DEFEATED**.

The AGM considered the following resolutions, which required a **simple majority** of the votes cast:

2022-12-06-AGM-13 (Simple majority required)

Resolution A-06. Presented by the Member Association of IRI (click here for details)

60 valid votes. 10 votes in favour. 50 votes against. 16.67 % in favour (4 abstentions).

The resolution was **DEFEATED**.

#### (Simple majority required)

Resolution A-07. Presented by the Member Association of ENG (click here for details)

143 valid votes. 141 votes in favour. 2 votes against. 98.60 % in favour.

The proposition was WITHDRAWN.

The Secretary General thanked the scrutineers for the work done.

#### 20. Election of the World Championships Finals 2025 host

The **President** announced that the draw made the day before determined that the order of presentations would be first Qatar and then Spain.

The AGM noted the presentations made by the Qatar Table Tennis Association (QTTA) for hosting the 2025 World Table Tennis Championships Finals in Doha, and the Royal Spanish Table Tennis Federation (RFETM) for hosting the 2025 World Table Tennis Championships Finals in Alicante.

The AGM allocated the 2025 World Championships Finals to the Qatar Table Tennis Association, to be held in the city of Doha.

#### 21. Future World Championships

#### 21.1 <u>Deadline for 2026 World Championships Finals Bids</u>

The AGM noted that the deadline of 30<sup>th</sup> June 2023 is set for the bids to host the 2026 World Table Tennis Championships Finals.

#### 22. Next General Meeting

The CEO indicated that following the discussions with the South African Table Tennis Board (**SATTB**), being the first World Championships to be held ever in South Africa, it was agreed that to ensure success in the event, the focus should be on the competition and the athletes. Therefore, it was proposed to hold the 2023 Annual General Meeting as part of the ITTF Summit 2023.

Mr Joe CARRIM, SATTB President and BoD member, concurred that having a Summit of the scale of the one in Amman would be difficult during the WTTC Finals, adding that what is important is to have the ITTF family coming to Durban. Mr CARRIM suggested that SATTB could still consider bidding to host the Summit, but in the third quarter of 2023, to ensure proper attention to both events, while -in agreement with the ITTF- still inviting the delegates of the Member Associations to attend for three days the WTTC Finals in Durban.

Mr CARRIM added that the possibility of engaging in the activities proposed by the Summit has a value that will be further enhanced with more interactive sessions in the future, suggesting that with more preparation time for the upcoming Summits, there will be even better outcomes.

Mr AL-MOHANNADI asked Mr CARRIM whether when SATTB bid for the WTTC Finals, they weren't also bidding for the AGM, as it happened in the previous 90 years, reflected on the small number of delegates present in Amman, and suggested that it is difficult for many countries to travel two times per year. Mr AL-MOHANNADI indicated that the AGM could be held three days before the World Championships, adding that for 2025, Qatar will bid for the AGM to welcome all the ITTF family for the AGM and World Championships.

#### 23. Any Other Business:

23.1 Mr Ali ALMADEH, delegate of BTTA, expressed his concern about the progressive reduction of the number of participants in the World Championships, indicating that despite the hard work being made, it is impossible for a country like Bahrain to qualify for the Finals. Mr ALMADEH asked QTTA (as the host of the 2025 WTTC Finals) to return to the old system and allow all countries to participate.

The CEO answered, reminding that there is a process in place to change the regulations <sup>9</sup>, and in this case (size and attendance to the World Championships) is through the Board

of Directors (BoD), to which any Member Association can present a proposition. The **CEO** continued explaining that the changes made were the result of a thoughtful three-year consultation process which involved an important investment and engaging professional companies in assisting in determining the best format for the event, adding that the goal is pursuing that all 227 Member Associations participate, whether in the same place, or through a qualification process, or through another innovative way.

23.2 Mr Munir Khondkar HASSAN, delegate from Bangladesh, requested that the AGM happens concurrently with the World Championships in the same place as otherwise (according to Mr HASSAN), it is very difficult to attend both events for some countries.

The Secretary General explained that following the adoption of Proposition 1 at today's AGM, there will be a process in place to determine the location for future AGMs, which will be decided by the AGM itself, therefore, not being a matter that can be discussed at this point of time.

23.3 Mr Andrew MUDIBO, BoD member, suggested that the WTTC Finals and AGM should happen concurrently for sustainability and economic reasons, adducing reasons such as the signature of the Sport for Climate Action or the lack of equipment companies representatives in the Summit.

The CEO answered that the hope for the ITTF Summit is to grow and that in an ideal scenario, a delegate of a member association should attend both the World Championships, to witness and support their team, and the Summit, to engage and focus on the relevant discussions that affect the sport. The CEO added that, in any case, this is a decision for the AGM to decide in 2023.

- 23.4 Ms Sachiko YOKOTA, delegate from the Japan Table Tennis Association (JTTA), indicated the interest of Japan in hosting the World Table Tennis Championships Finals in 2028.
- 23.5 Ms Claude BERGERET, BoD member, indicated that, reflecting on the words of Mr AL-MOHANNADI earlier in the day, encouraging more countries to organise ITTF and WTT events, she felt sorry for the RFETM, because the AGM had the opportunity to bring the World Championships to a new country; however, it was decided to allocate it to Qatar, which has organised many world level competitions recently. Ms BERGERET considered this as not a good sign, seeing it as a discouragement for smaller associations to bid for these events, however, wishing a big success to QTTA in the hosting of the event and congratulating them for winning the bid.
- 23.6 Mr HASSAN reflected on the fact that the BoD member from his region is not present in the AGM and asked whether he can represent India in the future or not, in view of the recent elections in TTFI. Mr HASSAN suggested that if the BoD member cannot represent India any longer, he would suggest that ATTU replaces that BoD member.

The Secretary General clarified that the power to remove a BoD member belongs to the BoD itself; therefore, to remove a member (and eventually replace him with another person), a vote by a two-thirds majority of the BoD is needed.

#### 24. Adjournment:

The **President** thanked the delegates for their commitment during the meeting, LUMI, as they were not responsible for the Internet problems, the scrutineers for the heavy workload, and the Secretary General, for running the meeting in these difficult circumstances.

The **President** highlighted that the cooperation of all delegates present was fundamental for the success of the AGM.

Not having any further business, the **President** adjourned the meeting at 18:35 Eastern European Summer Time.

#### Key Change 3: Review process to Propositions and Resolutions

- 11. The Secretariat occasionally receives propositions and resolutions that may be unclear, incomplete, or significantly harm the interest of the ITTF even without being adopted at the AGM or BoD meeting.
- 12. To assist the parties eligible to submit clear and workable Propositions and Resolutions, a review process for Propositions and Resolutions will be introduced, together with the various types of follow-ups to Propositions and Resolutions after their review.

#### Key Change 4: Patching gaps in the ITTF Constitution

- 13. The following gaps in the ITTF Constitution are addressed:
  - (a) The eligibility requirements and obligations of Member Associations are stated;
  - (b) The minimum requirements of Member Associations' and Continental Federations' statutes are stated;
  - (c) The conditions under which the ITTF may intervene in the governance or management of any Member Association and Continental Federation are stated;
  - (d) The new timelines to confirm the allocation of an AGM are defined;
  - (e) The conditions under which the Executive Committee and the AGM may sanction any Member Association are stated;
  - (f) The obligations of recognised groups of Associations are stated;
  - (g) The conditions under which the Executive Committee may vary deadlines are stated;
  - (h) The keeping of minutes and relevant documents for the AGM and BoD meetings clarified, together with the conditions to make minor corrections, are stated;
  - (i) The conditions under which any minor irregularity may be cured are stated;
  - (j) A clarification is made stating that the BoD may exercise its powers by signing a written motion;
  - (k) A clarification is made stating that connection to Table Tennis is a requirement for any IOC member to be appointed to the Executive Committee;
  - The conditions under which the President may remove the designation of the Deputy President and Executive Vice-President for Finances are stated;
  - (m) The power to fill any vacancy in the role of the Deputy President and Executive Vice-President for Finances is transferred to the President from the Executive Committee;
  - (n) The provision that Committees, Commissions etc. are governed by their terms of reference, unless specifically provided, is stated;
  - (o) The role of the Secretary-General is broadly described; and
  - (p) Savings provisions are made highlighting that the Executive Committee has residual powers to decide on any matter unaddressed in the ITTF Handbook.

#### Key Change 5: Definitions and interpretation

14. To reduce the repetition of commonly used definitions and interpretation rules across the ITTF Handbook, the new Preamble Chapter on **General Definitions and Interpretation Rules** will be created. Some examples of such common-used definitions are "AGM", "Association", "Athlete", "Official", and "Table Tennis Party". The necessary changes to other Chapters with the enactment of Chapter 11 will be taken.

#### Key Change 6: Formatting and language etc.

- 15. Non-substantive changes will be made to language, formatting, and other typographical matters. For example:
  - (a) reorganising the ITTF Constitution into 5 main parts (General Provisions, Associated Organisations, Bodies, Governance, and Administrative Matters) with further divisions in each part;
  - (b) using headings and sub-headings for clarity;
  - (c) using the gender-neutral pronoun of "they" to avoid gender bias and the lengthy term of "he/her";
  - (d) using Oxford comma in a list of items for greater clarity (e.g. "1, 2, and 3");
  - (e) using "Article" when referring to provisions in the ITTF Handbook (e.g. "Article 1.2.3"); and
  - (f) updating the term from "Junior" to "Youth".

To these 6 key changes, another 5 key changes are proposed to the Board of Directors, related to other sections of the ITTF Handbook.

Rationale:

The 2021 ITTF Annual General Meeting (**AGM**) resolved to establish the Governance Review Working Group (**GRWG**) to review, reorganise, and take such other steps it deems necessary to improve the ITTF Handbook.

As the ITTF Handbook has been amended over the years in a patchwork manner, this revision and reorganization are intended to enable the ITTF (and the wider ITTF Group) to provide its stakeholders with more clarity and improve consistency. This will help ITTF get aligned with modern, practical, suitable, and international practices and remain competitive in the sports and entertainment industry.

To the AGM are presented the changes affecting chapter 1, Constitution, and the proposition to adopt the "Preamble" including the General Definitions and Interpretation Rules. The Board of Directors will be presented with the changes affecting other rules and regulations not related to the Constitution and the Laws of Table Tennis.

The full text of the Preamble and the new Constitution is in Annex 1.

#### **GENERAL DEFINITIONS AND INTERPRETATION RULES**

This Chapter contains the definitions of commonly used terms in the Statutes and the rules of interpreting the Statutes.

The provisions in this Chapter apply generally to the Statutes, unless otherwise stated in any Chapter.

2. Manner of Interpretation

As the Statutes apply internationally, they are to be interpreted primarily with reference to generally accepted principles of international sport law and established sport jurisprudence (including that of the ITTF Tribunal and CAS), to the largest extent possible. Subject to the foregoing, the Statutes is governed by and interpreted according to the laws of Switzerland (excluding its conflict of laws rules).</li> <li>2.2. The provisions in the Statutes shall be interpreted in a manner that protects and advances their respective purposes. #### 1.3 NAME AND LEGAL STATUS

1.3.1 The International Table Tennis Federation (ITTF) is a not-for-profit association governed by Article 60 ff. of the Swiss Civil Code.

1.3.2 The ITTF is the sole international governing body of Table Tennis, as recognised by IOC.

#### 1.4 PRINCIPLES

1.4.1 The Principles of the ITTF shall be to:

- 1.4.1.1 operate with general unity of action, mutual respect of Associated Organisations in their dealings with one another, and non-discrimination against Associated Organisations or individuals on racial, political, religious, gender, or other grounds;
- 1.4.1.2 provide a sport and work environment in which all individuals are treated with respect and dignity;
- 1.4.1.3 ensure that each individual has the right to participate and work in an environment which promotes equal opportunities and prohibits discriminatory practices;
- 1.4.1.4 provide a sport environment free of harassment on any basis without exception and in accordance with the Statutes;
- 1.4.1.5 safeguard the environment and manage resources through its practices in hosting events and in managing its operations;
- 1.4.1.6 observe the general and fundamental principles of the Olympic Charter, the IPC Handbook, the World Anti-Doping Code, and their applicable subsidiary regulations, and no provision of this Constitution shall be deemed to conflict with or derogate from those principles; and

1.4.1.7 cooperate with the IOC, IPC, Association of Summer Olympic International Federations, Global Association of International Sports Federations, and other organisations that recognise it as the controlling and governing authority for Table Tennis throughout the world.
<ul> <li>1.5 OBJECTIVES</li> <li>1.5.1 The Objectives of the ITTF shall be to:</li> <li>1.5.1.1 uphold the principles of the ITTF and develop the spirit of friendship and mutual assistance among Associated Organisations and Athletes;</li> <li>1.5.1.2 regulate relations between Associated Organisations and between Associated Organisations and other organisations;</li> <li>1.5.1.3 seek continual improvement in the technical standard of Table Tennis and in the extent of participation in Table Tennis throughout the world;</li> <li>1.5.1.4 foster friendly sporting competition and eliminate unfair and unsporting practices, such as match manipulation, irregular and illegal betting, doping, and use of illegal equipment to enhance performance;</li> <li>1.5.1.5 establish, publish, and enforce the Statutes;</li> <li>1.5.1.6 promote and supervise World Title Events, Table Tennis competitions at the Olympic</li> </ul>

1.8.2.2 the jurisdiction it claims is clearly limited, in title and constitution, to the Territory in
which it controls Table Tennis; and 1.8.2.3 it is otherwise qualified for membership.
1.8.3 If an application is made under Article 1.8.2, the views of any Association from the Territory shall be considered and under no circumstance shall two Associations be
recognised as exercising authority over the same Territory. 1.8.4 Any organisation located outside any Territory may be granted temporary attachment
to an Association for the purpose of receiving aid in development and competition; the extended Territory shall be regarded as being within that Association's control, but approval of the attachment shall be reviewed at each AGM and shall not be renewed
indefinitely.
1.9 ADMISSION
1.9.1 Applications for membership shall be made in a form approved by the Executive Board and shall be submitted within 6 calendar months of the AGM at which the application is to be considered, except applications from former Associations.
1.9.2 Any application from any former Association may be accepted with immediate effect at the discretion of the Executive Board, without meeting the time limit stated in Article
1.9.1, and any such acceptance shall be ratified at the next AGM.
1.9.3 The Executive Board shall review all applications on behalf of the AGM and make recommendations on acceptance.
1.9.4 Applications for membership shall be considered at the AGM stated in Article 1.9.1 and shall be accepted with a Two-Thirds Majority of votes.
1.9.5 Where there is a Continental Federation in the continent in which the applicant organisation resides, the views of that Continental Federation shall be considered in reviewing that application for membership.
1.9.6 In the consideration of applications for a combined membership by Associations formerly in separate memberships, or for separate membership by Associations which were formerly components of an Association which has divided, or for recognition of changes in the Territory, the views of the organisations concerned and any circumstances outside their control shall be considered, and secession in other circumstances is not encouraged.
1.9.7 Any election to be an Association shall not be implicated by the political, diplomatic, or
national status of the Territory concerned, but shall only consider the conduct of Table Tennis therein.
1.9.8 Any organisation eligible for membership of the ITTF but having yet to apply for membership may, with the consent of the ITTF Council, be included in the appropriate Continental Federation for a period not exceeding 1 year, which is renewable at each

Athlete but only in the continent concerned.

Division 2: Continental Federations
1.19 CONTINENTAL FEDERATIONS
1.19.1 There shall be five Continental Federations, one each from the geographical regions
of Africa, the Americas, Asia, Europe, and Oceania.
1.19.2 Continental Federations shall be supported and encouraged by the ITTF, which shall
cooperate with them in all matters, provided that the statutes of the Continental
Federation comply with the Statutes.
1.19.3 Continental Federations shall not be regarded as agents of the ITTF and shall not hold
themselves out as such.
1.20 AFFILIATION WITH THE ITTF
1.20.1 The Continental Federations shall be affiliated to the ITTF according to established
criteria, prescribed by the ITTF Council following a proposal from the Continental
Council.
1.20.2 A Continental Federation's affiliation with the ITTF shall renew every 4 years, in the
year after the Olympic Games, subject to entering into a specific strategic quadrennial
agreement with the ITTF.
1.20.3 The affiliation of the Continental Federations has the following goals:
1.20.3.1 to increase cooperation in events and marketing as well to develop Table
Tennis cooperatively;
1.20.3.2 to formalise the status of Continental Federations within the Statutes;
1.20.3.3 to qualify for development funding in accordance with the agreement stated
under Article 1.20.2; and
1.20.3.4 to link continental events to the World Title Events to reinforce greater
marketing value and ensuring the participation of the top Athletes.
1.21 CONTINENTAL FEDERATIONS' RIGHTS
1.21.1 Each Continental Federation shall have the following rights, subject to the Statutes:
1.21.1.1 to submit Propositions and Resolutions for consideration for inclusion in the
agenda of the AGM or the ITTF Council meeting;
1.21.1.2 to be allowed to use the ITTF's name or logo as part of its trading name or
corporate identity, upon request and subject to the Executive Board's approval;
1.21.1.3 to have its Continental President be a member of the ITTF Council and the
Continental Council;
1.21.1.4 to have its championship title competition recognised as the sole continental
title championships for that continent; and
1.21.1.5 to exercise all other rights conferred under the Statutes.
1.22 CONTINENTAL FEDERATIONS' OBLIGATIONS
1.22.1 Each Continental Federation shall have the following obligations:

Division 3: ITTF Foundation

1.25 ROLE

1.25.1 The ITTF Foundation is the corporate social responsibility entity, a subsidiary of the ITTF, and a part of the ITTF Group.

### 1.26 ITTF FOUNDATION'S RIGHTS

- 1.26.1 The ITTF Foundation shall have the following rights:
- 1.26.1.1 to identify itself as stated under Article 1.25.1;
- 1.26.1.2 to set up one or more subsidiaries as necessary to meet its obligations under Article 1.27;
- 1.26.1.3 to submit Propositions and Resolutions for consideration for inclusion in the agenda of the AGM or the ITTF Council meeting;
- 1.26.1.4 appoint one or more representatives to attend the AGM; and
- 1.26.1.5 to exercise all other rights conferred under the Statutes.

### 1.27 ITTF FOUNDATION'S OBLIGATIONS

- 1.27.1 The ITTF Foundation shall have the following obligations:
- 1.27.1.1 to ensure that its statutes are not inconsistent with the Statutes;
- 1.27.1.2 to maintain its status as a legal entity in the territory where it is incorporated;
- 1.27.1.3 to promote and ensure the accessibility of Table Tennis; and
- 1.27.1.4 to organise events, carry out activities, or otherwise use Table Tennis to promote peace, solidarity, health, diplomacy, community development, and such other social good.

Division 4: World Table Tennis

## 1.28 ROLE

1.28.1 WTT is the commercial rights entity, a for-profit subsidiary of the ITTF, and a part of the ITTF Group.

## 1.29 WTT'S RIGHTS

1.29.1 WTT shall have the following rights:

- 1.29.1.1 to identify itself as stated under Article 1.28.1;
- 1.29.1.2 to exercise all rights, entitlements, benefits granted under the licence agreement with the ITTF;
- 1.29.1.3 to set up one or more subsidiaries as necessary to meet its obligations under Article 1.30;
- 1.29.1.4 to appoint one or more representatives to attend the AGM;1.29.1.5 to submit Propositions and Resolutions for consideration for inclusion in the
- agenda of the AGM or the ITTF Council meeting; and
- 1.29.1.6 to exercise all other rights conferred under the Statutes.

# 1.30 WTT'S OBLIGATIONS

- 1.30.1 WTT shall have the following obligations:
- 1.30.1.1 to ensure that its statutes are not inconsistent with the Statutes;
- to maintain its status as a legal entity in the territory where it is incorporated;
   to exploit the licensed commercial rights in accordance with the licence agreement and such other agreements granted by the ITTF;

<ul> <li>1.30.1.4 to promote and maintain the commercial sustainability of the licensed events;</li> <li>1.30.1.5 to enhance, promote, professionalise, and develop the prestige and image of Table Tennis; and</li> <li>1.30.1.6 to drive the growth of Table Tennis by developing the areas of top Athlete participation and prize money, broadcast production and content distribution, event production, presentation and fan experience, marketing and promotion, tournament hosting and event operations, competition format, calendar and structure, and Athlete management.</li> </ul>
Division 5: Other Associated Organisations
<ul> <li>1.31 OTHER GROUPS OF ASSOCIATIONS</li> <li>1.31.1 A group of Associations shall, in principle, include those that share common objectives, such as promotion of Table Tennis in any of its forms or categories, organisation of competitions for specific titles or for areas united by language, history and/or culture.</li> <li>1.31.2 Each recognised group of Associations shall have the right to organise specific competitions open to all the Associations of that group, provided that the Statutes are observed in respect of play with unaffiliated organisations.</li> <li>1.31.3 Each recognised group of Associations shall have the following obligations:</li> <li>1.31.3.1 to fully comply with the Statutes and all decisions taken in accordance therewith;</li> <li>1.31.3.2 to administer, promote, and develop Table Tennis according to the Principles and Objectives;</li> <li>1.31.3.3 to adopt statutes which comply with the Statutes;</li> <li>1.31.3.4 to immediately notify the ITTF about any major change concerning it, such as its constitution or regulations, its President or Secretary General, its address or contact details, and provide such other information required under the Statutes;</li> </ul>
<ul><li>1.31.3.5 to ensure that its own members to comply with the Statutes; and</li><li>1.31.3.6 to comply with any other prescribed requirements.</li></ul>
Division 6: Authority of Associations
<ul> <li>1.32 MEMBERSHIP AND REPRESENTATION</li> <li>1.32.1 An Athlete shall be regarded as resident in a Territory if their ordinary or main residence or base is in that Territory but residence shall not be solely determined based on duration stayed in that Territory.</li> <li>1.32.2 Before accepting an Athlete into membership, an Association shall satisfy itself that such Athlete is or intends to be resident in its Territory and it shall not retain them if they terminate such residence.</li> </ul>
<ul> <li>1.32.3 Unless notified of any suspension or expulsion, Associations shall be entitled to regard any Athlete or organisation resident in the Territory of an Association and known to have been affiliated to it as eligible for participation.</li> <li>1.32.4 Except after a genuine change of residence, no Association may make a resident in a Territory controlled by another Association a member or representative of itself without the prior permission of that other Association.</li> <li>1.32.5 Any dispute under Article 1.32 shall be referred to the Executive Board.</li> </ul>
<ul> <li><b>1.33 EXTENT OF AUTHORITY</b></li> <li>1.33.1 In administering and interpreting its own regulations and decisions, an Association shall have authority over:</li> <li>1.33.1.1 Athletes residing in its Territory, while they are in that Territory or in any other Territory;</li> <li>1.33.1.2 visiting Athletes, while they are in its Territory, except as provided in Article 1.34.1; and</li> </ul>

1.33.1.3 Athletes representing it in a competition who are normally resident in the Territory of another Association, but only while they are taking part in that
competition.
1.34 VISITING ATHLETES
1.34.1 If a visiting Athlete is officially representing their Association or the ITTF in a Veterans event pursuant to an invitation by the visited Association, the visited Association has no right to impose any penalty on that Athlete.
<ul> <li>1.34.1.1 The responsible management committee shall have authority over the conduct of the competition, but no subsequent penalty may be imposed on a visiting Athlete for any offence committed in connection with that competition.</li> <li>1.34.1.2 The visited Association may protest to the visiting Athlete's Association or the ITTF in Veterans events about any offence, but the visiting Athlete's</li> </ul>
Association shall retain sole authority over them and the right to impose any penalty.
1.34.2 If a visiting Athlete participates in Table Tennis activities other than as an official representative of their Association, whether their visit is pursuant to an invitation by the visited Association, they shall be subject also to the authority of the visited Association, which shall have the right to impose any penalty for any offence committed in connection with such activities.
1.34.2.1 No such penalty may come into operation until at least 1 calendar month after its notification with an account of all the circumstances to the visiting Athlete's Association.
1.34.2.2 If the visiting Athlete's Association makes no appeal within 1 calendar month of being notified, the penalty may be imposed.
1.34.2.3 If an appeal is submitted within 1 calendar month, the matter shall be referred to the Executive Board and the penalty may not come into operation before the appeal has been decided.
<ul> <li><b>1.35 PAYMENTS TO PLAYERS</b></li> <li>1.35.1 Except when acting under the direct instruction of their Association as its representative, an Athlete may accept any payment, reward, benefit, or allowances for playing in any competition other than the Olympic and Paralympic Games, or for exhibition or coaching.</li> </ul>
<ul> <li>1.35.2 Subject to Article 1.35.1, each Association shall have absolute discretion to determine and regulate its own policy for any payment, reward, benefit, or allowance in respect of Athletes and events under its jurisdiction.</li> </ul>
Division 7: Unaffiliated Players and Organisations
<ul> <li><b>1.36</b> OBJECT OF REGULATION</li> <li>1.36.1 The object of this Part II, Division 7 is to regulate, but not to prevent, play between affiliated and unaffiliated Athletes.</li> </ul>
1.36.2 Only teams and Athletes nominated by Associations may participate in World Title Events and continental championship events, but otherwise such Athlete will, when not contrary to the Statutes or to the interests of the ITTF or of the Associations, generally

organisation is not affiliated to the ITTF shall not take part in any competition,
exhibition, or coaching in the territory of any Association, except with the permission of
the Executive Board, unless the ITTF Council has previously given permission for the
governing organisation to be included temporarily in the appropriate Continental
Federation pending an application for membership.
1.36.6 The Executive Board may permit any Table Tennis event to be organised by an
unaffiliated body provided that:

Text 1:

#### Net in the game can have disadvantageous effects for several reasons:

**Time:** According to item 2.9.1.1 the repetition of the net leads to a let and is unlimited as you can see in the video, a player netted 5 times in one service, and this will affect the length of the game and cause tension

**Psychological:** if the ball hits the net during the service, there is an interruption the match and if this action repeated again, the opponent is confused in terms of concentration and mentality.

Sometimes, failure to recognize the net in time causes the players' rights to be lost. In the continuation of the match, it may cause tension between the umpire and the player.

**Moral:** The opponent may not be able to receive well and cleverly, before the umpire announcement, raise his hand to mark the let after the first reception to make an interruption. Sometimes the umpire and assistant umpire do not see the net. This also makes tension between the umpire and the player.

**Physically:** In addition, in many national and some international competitions, there is often no assistant umpire, and this makes judging difficult. Umpire should concentrate on the service so much which cause difficulty in his judgment and has the negative effects on his judgment in continuation of the match.

Text 2:

#### Remove time-out Removal of time out from matches:

According to items 3.4.4. in Handbook, the player can be informally guided by the guidance of his coach in various situations during the rally which has been added to the handbook after the time out law. Therefore, the time-out discussion will have a negative advantage and will increase the game time and cause interruption. It would be better to remove the time-out.

#### Rationale1:

Like some other sports, (Badminton, and Volleyball) it is suggested to remove the net from the let subgroup. Because by removing Net, many of the mentioned cases will be solved. And in long games which lead to expedite system, it helps not to increase the time of the game.

Rationale 2:

It is suggested that the time-out should be removed from the entire game and two minute should be reduced from the game time, considering that the players can get help at any time. As a result, it will be attractive for television and media broadcasting and attract the audience.

Removing time-outs and nets from matches has an effect on not prolonging the playing time (especially defensive players, which leads to the expedite system).

Table Tennis England, supported by the other Home Nation Associations from Great Britain (Guernsey, Isle of Man, Jersey, Scotland and Wales) and with the support of British Para Table Tennis, request that the ITTF award Table Tennis England 'preferred bidder status' for the 2026 World Team Championships and 2026 World Para Championships in order that it can seek funding and compile the best bid to host these events in the ITTF Centenary back in the city where it all began, London.

Table Tennis England, in collaboration with the Home Nation Associations listed will present to the 2023 ITTF AGM the details of the London bid for evaluation and decision. The bid will showcase the first ever integrated World Championships in a World Class venue in the city of London, showing the whole world the inclusivity of our wonderful sport in the 100th year of the ITTF.

Rationale:

The first World Championships was held in 1926 in London, the birthplace of the ITTF in the same year.

Table Tennis England, which celebrated its own centenary in 2021/22, has been in discussion with the ITTF since 2019 concerning how best to maximise the impact of the 2026 Centenary World Championships.

We now request that the ITTF AGM grants the status of preferred bidder for the Championships to London.

This is a similar principle to that adopted by the International Olympic Committee towards the City of Brisbane, Australia, which went on to be awarded the 2032 Olympic Games.

Such a status would allow Table Tennis England to present the optimal bid to stage the 2026 World Championships and celebrate the centenary in the city where it all started.
