ITTF COUNCIL MEETING

MINUTES of a meeting of the ITTF Council held in a hybrid format on Wednesday, 23rd August 2023, starting at 14h00 ICT (07h00 UTC).

1. President's Welcome and Opening Address

The **President**, Ms Petra SÖRLING, welcomed the Members of the ITTF Council in attendance, both physically and remotely, reflecting on the positive exchanges during the first day and a half of the Summit, and suggesting to the attendees online to be actively participating.

2. Roll call, welcome and Ratification of new members

A total of 41 ITTF Council Members were present (38 at the start of the meeting) with the apologies of Mr Roland NATRAN, Mr Mohamed ALDAEIKI, Mr Thomas KIGGUNDU, Mr Alexander ZAMORA and Mr Scott HOUSTON.

During the roll call, the attendance of the ITTF Tribunal Chair, the ITTF Integrity Board Chair, the three (3) ITTF Commissioners, the seven (7) Committee Chairs, and the two Senior Advisors was also confirmed.

3. Confirmation of the Minutes of the Board of Directors Meeting held on 4th December 2022:

Not having any remarks on the ITTF Board of Directors Meeting from 2022, the ITTF Council proceeded to vote.

7. Appointment of new Members to the Integrity Board

The ITTF Council noted the presentation made by Mr Enric RIPOLL, Chair of the Integrity Board, of the proposed candidates to become members of the Integrity Board:

Mr Wayne SNELL, from Australia, specialised in investigations, Mr Jonathan GRAY, from United Kingdom, specialised in strategy & operations, and Ms Erika RIEDL, from Switzerland, also specialised in strategy and operations.

The ITTF Council agreed to consider the proposed alternative candidates in case any of those appointed would not remain available.

38 valid votes. 36 votes in favour. 2 votes against. 94.74% in favour (0 abstentions).

The President congratulated the ITTF Council for this decision, having now a complete Integrity Board composed of such high-quality Members.

8. Appointment of Members of the Sustainability Committee

The ITTF Council was presented with the proposed candidates to become members of the Sustainability Committee, noting that no candidates were received from the Americas and Oceania.

The ITTF Council agreed to appoint the proposed Sustainability Committee Members.

38 valid votes. 37 votes in favour. 1 vote against. 97.37% in favour (0 abstentions).

9. The Future of the World Cups

Mr DANTON informed the ITTF Council that the Men's and Women's World Cups will be back in the ITTF calendar in 2024, and that the Mixed Team World Cup will be introduced, already in 2023, hoping for this event to become a permanent fixture in the ITTF calendar. Mr DANTON thanked Mr LIU Guoliang for the support in making the return of the World Cups possible.

10.2. Busan 2024 Intercontinental Stage proposed replacement

The ITTF Council noted the presentation from the ITTF Sports Director, Mr Mikael ANDERSSON, on the difficult feasibility of the Intercontinental Stage for the Busan 2024 WTTTC Finals and the proposed alternative, allocating one additional quota per Continental Federation and the sixth quota for World Ranking.

10.3. Busan 2024 WTTTC Finals Format of Play

The ITTF Council noted the presentation from the ITTF Sports Director, Mr Mikael ANDERSSON, on the two options proposed for the format of play of the second stage of the Busan 2024 WTTTC Finals (with two or three teams progressing from each group of the preliminary stage to the main draw).

Option A: 2 teams progressing to the main draw from each group

Option B: 3 teams progressing to the main draw from each group

2023-08-23-IC-24 (simple majority required)

Proposition IC-2023-21. Proposed by the ITTF Continental Council ([click here for details](#))

35 valid votes. 13 votes in favour of option A (37.14%). 22 votes in favour of option B (62.86%), 1 abstention.

The Option B was **PASSED**.

10.4. Paris 2024 Paralympic Games Format of Play

The ITTF Council noted the presentation from the ITTF Sports Director, Mr Mikael ANDERSSON, on the proposed format of play for the Paris 2024 Paralympic Games, introducing the knock-out format, as in the WPTTC Granada 2022, improving the seeding separation by world ranking.

34 valid votes. 33 votes in favour. 1 vote against. 97.06% in favour (1 abstention).

The proposition was **PASSED**.

11. Competition Updates

11.1. World Title Events

The ITTF Council noted the presentation from the ITTF Sports Director, Mr Mikael ANDERSSON, on the introduction of a Mixed Team World Cup, which first edition will be held in December 2023, with a new format in the team matches competition.

Mr ANDERSSON also referred to the return of the World Cups, and the connection to be established with the Continental Cups as part of the qualification pathway.

11.2. World Youth Events

The ITTF Council noted a brief update on the World Youth Championships to be held in Nova Gorica, Slovenia, in 2023, and the two bids received for the WYC 2025 from Bahrain and Romania.

11.3. World Veteran Events

The ITTF Council noted that over 4000 entries have been received to date for the World Masters Championships to be held in Rome, Italy, in July 2024, with the possibility to go over 6000 participants. The bids for the 2026 will be open in the coming weeks.

11.4. Para Table Tennis

The ITTF Council received an update on the Para Table Tennis calendar planning progress for 2024.

12. Election of the 2025 World Youth Championships host

The ITTF Council noted the presentations of the Romanian Table Tennis Federation (RTTF) and the Bahrain Table Tennis Association (BTTA) for hosting the World Youth Championships 2025 in the cities of Cluj and Manama, respectively.

After the presentations, Sheikha HAYAT, the President of the Bahrain Table Tennis Association, indicated that based on the long and good relationship between BTTA and RTTF and the important milestone for RTTF in 2025, BTTA wished to withdraw their bid in favour of RTTF, hoping to have the chance to host the WYC 2026 in Bahrain.

In turn, Mr Cristian CRETU, Deputy General Secretary of RTTF thanked Sheikha HAYAT and BTTA for their kind gesture and support and requested the ITTF Council's support to allocate the WYC 2026 to BTTA.

Mr Anthony MOORE, President of ITTF-Oceania, suggested making a motion from the floor by the ITTF Council to the ITTF AGM to allocate the 2026 WYC to the BTTA.

The Secretary General confirmed that following the allocation of the WYC 2025, the ITTF Council can effectively put forward such proposition to the ITTF AGM.

2023-08-23-IC-26 (simple majority required)

36 valid votes. 36 votes in favour. 0 votes against. 100% in favour (0 abstentions).

The ITTF Council allocated the 2025 World Youth Table Tennis Championships to the Romanian Table Tennis Federation, to be held in the city of Cluj.

2023-08-23-IC-27 (simple majority required)

35 valid votes. 35 votes in favour. 0 votes against. 100% in favour (1 abstention).

The ITTF Council agreed to put a motion from the floor to the ITTF AGM to allocate the 2026 World Youth Table Tennis Championships to the Bahrain Table Tennis Association, to be held in the city of Manama.

The ITTF Youth Commissioner, Ms Heike AHLERT, congratulated BTTA and RTTF for their quality bids, thanked BTTA for the gesture with RTTF, and expressed her satisfaction for the decision and proposal made by the ITTF Council.

13. Next ITTF Council meeting

The ITTF Council noted that its next meeting would be held on Monday 26th February 2024 in Busan, Korea Republic.

14. Any other business

14.1. Personal Honorary Membership of Mr Zdenko KRIZ.

The ITTF Council considered the proposition from the Slovak Table Tennis Association to appoint Mr Zdenko KRIZ as an ITTF Personal Honorary Member.

2023-08-23-IC-28 (simple majority required)

37 valid votes. 36 votes in favour. 1 vote against. 97.30% in favour (0 abstentions).

The ITTF Council agreed to propose Mr Zdenko KRIZ to become an ITTF Personal Honorary Member at the ITTF AGM 2023.

14.2. Personal Honorary Membership of Mr Cherif HAJEM.

The ITTF Council considered the proposition from the Slovak Table Tennis Association to appoint Mr Cherif HAJEM as an ITTF Personal Honorary Member.

2023-08-23-IC-29 (simple majority required)

37 valid votes. 36 votes in favour. 1 vote against. 97.30% in favour (0 abstentions).

The ITTF Council agreed to propose Mr Cherif HAJEM to become an ITTF Personal Honorary Member at the ITTF AGM 2023.

(simple majority required)

Proposed by the ITTF Executive Board

World Youth Table Tennis Championships Expansion

(On the recommendation of the ITTF Youth Commissioner, Heike AHLERT, the ITTF Technical Commissioner, Graeme IRELAND, and the Competition Department)

(Simple majority is required)

According to the ITTF regulations:

The system of play and the system of qualification in the team and individual events shall be decided by the Council (old Board of Directors), on the recommendation of the Junior Commissioner, Technical Commissioner, and the Competition Department and shall be notified to all Associations not later than 6 calendar months before the start of the Championships.

The ITTF EB proposes to amend the qualification system for ITTF World Youth Table Tennis Championships as follows:

Amendments proposed in green highlight are for the implementation of:

Proposition B-22 (Approved on 2022 ITTF BoD)

Proposed by the Member Association of JPN

To amend the entry system for ITTF World Youth Table Tennis Championships so that when a Member Association (MA) that has qualified as a team may alternate a different player in the singles than the player who have qualified under WR depending on the number of players who have qualified under WR.

Rationale:

When a MA participates in the World Youth Championships through the World Youth Qualifiers, if there is no WR holder among the members or if their WR is significantly low, we would like each NF to be able to use a member who has won at the National Qualifiers.

The reason is that in the non-professional youth generation, only those who have competed in international tournaments have WRs, which are often out of proportion to their actual ability. (i.e.)

Result of National Qualifiers

Winner: Player A, Runner-up: Player B, 3rd: Player C, 4th: Player D, 5th: Player E

WR order

1st: Player E, 2nd: Player D, 3rd: Player A, 4th: Player B, 5th: Player C

1st: Player A, 2nd: Player B, 3rd: Player C, 4th: Player D

Singles event participant

Amendments in **yellow highlight** are proposed for the implementation of the following:

ITTF Executive Board Proposition

To amend the qualification system for ITTF World Youth Table Tennis Championships so the number of quotas in U15 events would be increased as follows:

- U15 Team 8 → 12 Teams (per gender)
- U15 Singles 24 → 32 Players (per gender)
- U15 Doubles 12 → 16 Pairs (per gender)
- U15 Mixed Doubles 24 → 32 Pairs

Rationale:

Providing opportunities for more Member Associations to be represented in the U15 events will give the chance for more young players to participate in a world title event.

Having more quotas available, more young players will have the qualification for the WYC as a realistic goal.

Equal number of quotas in U15 and U19 events provides a clearer and more solid qualification system.

Amendments in **grey font and highlight** are cosmetic changes or clarifications of current regulations.

No replacements are permitted in Singles except for a Member Association (MA) that has qualified in the same age category as a team that may alternate a different player in the singles than the player who have qualified under WR depending on the number of players who have qualified under WR.

Players qualified in Continental events which participation is not confirmed are not anymore entitled to play the Singles event in the age category they were originally qualified.

In case a Semi-Finalist from a Continental event is invited, and respective participation is not confirmed by the Member Association, the player is not anymore entitled to play the Singles event in the respective age category for which the invitation hasn't been confirmed or was declined.

(On the recommendation of the ITTF Technical Commissioner, Graeme IRELAND, and the ITTF Group Sports Director, Mikael ANDERSSON, with the agreement of the two Executive Board Members in charge of Olympic Games, ITTF President, Petra SÖRLING, and IOC Member, RYU Seung-Min)

According to the ITTF regulations for Olympic Games:

The Team Match System in team events and the system of play in both team and individual events, including any qualifying competitions, shall be decided by the ITTF Council (old Board of Directors) on the recommendation of the ITTF Continental Council.

Following the discussions held at the Continental Council, ITTF Technical Commissioner Graeme IRELAND and ITTF Group Sports Director Mikael ANDERSSON submit the following proposition.

Playing system – Paris 2024 Olympic Games**The following playing formats are recommended for the Paris 2024 Olympic Games:****1. Team Event**

Given the short lead-up time to the Paris Olympic Games, we are at this point recommending maintaining the current match system as defined in the ITTF Handbook 3.7.6.3. (the same as in Tokyo 2020).

3.7.6.3 Best of 5 matches (4 singles and 1 doubles).

3.7.6.3.1 A team shall consist of 3 players; each player shall compete in a maximum of 2 individual matches.

3.7.6.3.2 The order of play shall be

- 1) doubles B & C v Y & Z
- 2) A v X
- 3) C v Z
- 4) A v Y
- 5) B v X

The general view here is that any changes related to the Olympic Games Table Tennis Competitions should be based on in-depth studies and with sufficient lead-up time to organise top-level test events.

To remove the doubles from the team match system already for Paris 2024 is also considered negative, especially given the ongoing ITTF drive to include the doubles into the future Olympic Games programs. We are of the firm opinion that the ITTF should initiate a study on future innovative team match system with the ambition to introduce a unified system of play suited for all ITTF team competitions starting from the year 2024. Such a process could potentially lead the way for introducing a new match-system, together with additional doubles events, for the Los Angeles 2028 Olympic Games.

Furthermore, modifying the WTTC Finals Match system for Busan has been discussed due to the connected qualifying principles for Paris 2024. In this case, our strong opinion is to remain with the

current WTTC system (New Swaythling Cup 5 singles) for the Busan 2024 WTTC Finals. Although not 100% ideal (to use a different format of play for the WTTC Finals, serving as a qualification event for the Olympic Games), we are considering that using different systems will have very little impact on the actual results. The best teams will remain the best regardless of the system to apply. Therefore, Busan 2024 is a fair trial for the Olympic Games. The same goes for other continental events using different match systems for the team competition. On top of that, clearly, the integrity of the WTTC Finals, as a stand-alone, extremely important ITTF event, must be prioritised.

Recommendations – Summary – Team Events

- **To play the Paris 2024 Olympic Games Team Competition with the same system as Tokyo 2020, 1 doubles' and 4 singles' match system, and each athlete competing in a maximum of two individual matches. (3.7.6.3., as described in this document)**

2. Singles Event**Background**

Originally, in Seoul 1988, Barcelona 1992, and Atlanta 1996, the playing system for singles was groups followed by knockout, but this was changed in Sydney 2000 to have a “staggered” knockout system whereby seeds 1 – 16 did not enter until round 3 and seeds 17 – 32 did not enter until round 2. Whilst the intention was to provide matches between closely ranked athletes for all rounds, the downside was that the top seeds did not have any competition until the third round, and, as a result, there were a number of upsets.

Tokyo 2020

For example, in Tokyo 2020, we had an average of 23 % upsets in the initial three Men’s singles rounds. However, the underdogs did much better in the Women’s singles competitions, winning 43 % of their matches and with two athletes advancing from the preliminary round into the last 16 round.

Straight knock-out draw

We are now suggesting that the playing system in **Paris 2024 goes to a straight knockout system.** This would be based on a draw of 64, with any additional athletes ranked below 64 (maximum of 6 but will be several fewer depending on mixed doubles qualifiers) playing a preliminary round, drawn against athletes ranked 49-64, to determine final places.

The most significant upside with the straight knockout system is that **we can now expose top-seeded athletes from day one in the singles competition, which will be very attractive for spectators and media.** The proposed system, with different seeding groups, also provides reasonable protection for athletes holding seeding positions 17-32, which early on was considered to be a priority.

Seeding and Draw system

The draws for the singles events are carried out as follows:

The singles events follow a direct elimination format. In both the Men's and Women's singles events, there will be a maximum of 70 athletes, with no more than two athletes from the same gender from any NOC.

The top 16 seeded athletes are drawn directly into the round of 64. The athlete seeded 1 is placed into position 1, and the athlete seeded 2 is placed into position 64. The athletes seeded 3 and 4 are drawn into positions 32 and 33; the athletes seeded 5, 6, 7 and 8, are drawn into positions 16, 17, 48 and 49; the remaining eight athletes are drawn into positions 8, 9, 24, 25, 40, 41, 56, and 57.

The next 16 athletes (seeded 17 to 32) are then drawn into positions 4, 5, 12, 13, 20, 21, 28, 29, 36, 37, 44, 45, 52, 53, 60, and 61.

The remainder of the draw depends on the number of athletes in the event:

- If there are 64 or fewer athletes, the remaining athletes (athletes seeded 33 up) will be drawn into any remaining position, subject to byes being allocated first.
- If there are more than 64 athletes in the event, the remainder of the draw is carried out as follows:
 - The next 16 athletes (seeded 33 to 48) are drawn directly into any remaining position.
 - The athletes seeded 49 to 64 are drawn into the preliminary round (16 matches) into the top place of each match. The remaining n athletes are then drawn into the preliminary round (making n matches) into the bottom place of each match. Any athletes, who do not have opponents, and the n winners of the n preliminary round matches will advance to the round of 64.

In all draws, **athletes from the same NOC must always be drawn into opposite halves of the draw**. During the draw, the referee will ensure the draw actions are presented in such a way that allows OC Technology (OVR) to capture the actions as they occur.

Recommendations – Summary – Singles Events

- **To apply** the straight knock-out system for Paris 2024 Olympic Games - Main Draw of 64 athletes
- **To use seeding protection** for the groups 1-16 and 17-32.
- **To use separation by NOCs** – two athletes of the same NOC must be drawn into opposite halves.

Rationale:

The player's name on the back of the shirt is already a mandatory requirement for Olympic and Paralympic competitions. It has been further implemented in World Title Events, especially when back numbers were not applicable, i.e., World Youth Championships, World Championships, and World Para Championships. It should be a standard requirement for better and clearer identification of players. Most players already have their names printed on the back of the shirts for other International Events.

Article 7.1.1.1: Harassment is a form of discrimination. Harassment is prohibited by human rights legislation and is considered unlawful in many States of the world. **It is also prohibited by this ITTF Anti-Harassment Policy.**

Rationale:

*The goal of this addition to this provision is to explicitly and specifically state that harassment is prohibited by the ITTF regulations. Accordingly, the ITTF Integrity Unit can receive complaints **resulting from the violation of this prohibition.***

It can also assist in the formal resolution of complaints and decide whether or not to initiate proceedings before the ITTF Tribunal (article 7.5.2). Violation of the harassment prohibition would also specifically give the ITTF Tribunal jurisdiction to hear and decide any alleged infringement of any ITTF rule, pursuant to article 8.15.1.

PROPOSITION IC-2023-07 – PASSED

8.15.4.2 unless otherwise specified in any provision of the ITTF Handbook, the Request for Proceedings of the appeal must be filed with the ITTF Tribunal no later than 21 days after the date that the appealing party receives the decision in question. **This 21-day deadline to appeal may not be extended.** The decision being appealed will remain in full force and effect pending determination of the appeal, unless the Hearing Panel (or the ITTF Tribunal Chair, if the Hearing Panel has yet to be formed) orders otherwise;

Rationale:

Like the CAS Code of Sports-related arbitration (article R32(2) of the CAS Code), the 21-day deadline to appeal a decision may not be extended. All other deadlines fixed by the ITTF Tribunal may be extended in accordance with article 8.21.4, provided however that the deadline for which the extension is requested has not yet expired.

8.21.4 Upon application on justified grounds and after consultation with the other party (or parties), the Hearing Panel Chair (or the ITTF Tribunal Chair, if the Hearing Panel has yet to be formed) may extend ~~the~~ any time limit provided in these ITTF Tribunal Regulations, **except the 21-day deadline to appeal provided at article 8.15.4.2, if the circumstances so warrant and provided that the time limit for which the extension is requested has not already expired.**

Rationale:

The added text is identical to the corresponding text in article R32)2) of the CAS Code. The purpose of this amendment is to ensure the legal certainty. Once a deadline has expired, it may no longer be extended.

8.18.2 Any party wishing to rely on documents written in a language other than the language of the procedure must provide certified English translations at their own cost.

8.18.3 Any party who wishes or whose witness wishes to give oral evidence in a language other than the language of the procedure must bring an independent and competent translator to translate that evidence into English, at their own cost.

Rationale:

The goal of this amendment is to avoid that the parties may agree to choose to proceed in a language, that none of the members of the ITTF Tribunal speaks well, or, worse, even if one the members of the ITTF Tribunal speaks such a language, there may not be two other members who would speak the same language to form a three-member panel. Therefore, the Chair of the ITTF Tribunal shall approve the parties choice of a language of procedure other than English and that choice cannot be imposed on the ITTF Tribunal.

As a result of the ITTF Board of Directors' decision in 2020 to have 40 teams compete at the World Team Table Tennis Championships in the final stage, we request the ITTF Council to increase the number of teams participating in the World Table Tennis Championships Finals from 40 to 64 starting in 2026.

The specific proposal is:

1. As there are 64 teams participating in the WTTTC Finals, the top 32 teams will play in Division 1 and the other 32 teams will play in Division 2.
2. Top 32 teams will be determined by the results of the previous World Team Table Tennis Championships Finals or by the ITTF Team Ranking. In addition to the top 32 teams, the remaining 32 would be selected by qualification tournaments with regional, continental, and intercontinental participation, based on existing mechanisms, with continental distribution as well as the host if not already included.
3. Four (4) teams will be promoted from Division 2 of the WTTTC to Division 1 of the subsequent WTTTC, while four (4) teams will be relegated from Division 1 to Division 2 of the subsequent WTTTC.
4. The 32 teams in Division 1 will be divided into 8 groups of four teams to play in a round-robin system, with the top two (2) teams advancing to Stage 2, where they will play in a knockout system to determine the top 16. In each group, the third and fourth place finishers would progress to Stage 2, where they would compete in a knockout system to determine the positions from 17 to 32. In the upcoming WTTTC, the winners of the first knock-out match (for positions 17-32) will be guaranteed a place in the first division and will not need to play any further matches. The losers of the first knockout match (for positions 17-32), play another match to determine the last four teams that will be relegated to Division 2 in the subsequent WTTTC.
5. For Division 2, 32 teams will be divided into eight groups of four teams to play in a round-robin format, with the top two (2) teams progressing to Stage 2, where they will play in a knockout format. The top four (4) teams from Stage 2 will be promoted to Division 1 of the subsequent WTTTC.

Rationale:

1. *The vast majority of ITTF Member Associations place a great deal of importance on team events. A wider representation of teams from all continents would be possible at the World Team Table Tennis Championship Finals by adding 24 teams.*
2. *The addition of 40 teams to 64 will also provide more motivation for weaker/growing teams on each continent to promote table tennis.*
3. *With 64 teams participating, more countries would be able to participate in the World Team Table Tennis Championships Finals, promoting the growth of table tennis worldwide.*

PROPOSITION IC-2023-10 – PASSED

4. *A divisional structure for the future WTTTC would enhance competitiveness, ensuring that teams are matched against opponents of similar skill levels, resulting in more competitive matches.*
5. *Division 2 will allow emerging teams to gain experience and exposure at the international level, fostering global development for the promotion of table tennis.*
6. *Having a promotion and relegation mechanism allows teams to earn their place in the top division based on performance, ensuring a fair and dynamic advancement pathway.*
7. *The proposed revised format for the World Team Table Tennis Championships Finals, which accommodates 64 teams in two divisions, offers a balanced and inclusive approach to the tournament. As a result of adopting this revised format, the ITTF would be able to increase participation, promote global representation, and create an event for the entire table tennis community, including players and fans, that is more captivating and competitive.*

To ensure the continued growth and development of table tennis in the world, we urge the esteemed members of the ITTF to consider and adopt this proposal.

Following the decision of the ITTF Board of Directors in 2020 regarding the future World Team Table Tennis Championships to have 40 teams in the final stage of WTTC, we would request the ITTF Council the possibility to increase the number of teams participating in future World Table Tennis Championships Finals to be 64 instead of 40.

Rationale:

1. *Increasing the number of participating countries in the tournament from 40 to 64 would provide a more equitable opportunity for many participating countries. (having in consideration the fair and equitable mechanism for selecting the added number for each continent).*
2. *It would provide a significant incentive for all nations to prepare, participate and promote a spirit of competition on a larger scale.*
3. *This proposal emphasizes the importance of updating and advancing every country, regardless of their current levels. The objective is to enhance progress in all countries, irrespective of their technical capabilities.*
4. *The sports authorities in the member countries will increase their support for their national Association, as the possibility of participation and achieving advanced results has become possible through increased participation.*
5. *Undoubtedly, this proposal presents an opportunity and a grant for many countries to exert more effort in achieving the best achievements.*
6. *Countries will work on improving their ranking classification from one to another, which will serve as a benchmark for participating countries' performance.*

Additionally, to the transferred content, text has been added with an administrative purpose, to describe the brand and manufacturers responsibility during the approval or authorisation procedure. Policy changes in the added part are written in an additional proposition.*
- b) *The document title description “Technical Leaflet” no longer reflects the content of the document. The document contains all facets that are of administrative and technical importance for the respective equipment. Therefore, the name MANUAL was chosen instead of Technical Leaflet, because the former name only refers to the technical parts. Inside the MANUAL all information for the Brands, Manufacturers and Athletes are included.*
- c) *Based on the proposition, that the documents will no longer be called “Technical Leaflet”, all sentences and wordings in the new Manuals should be changed to the new document name.*

The wording used on the packing may not contain false sponsorship's claims.

Rationale:

- a) This policy has been used for the past years when a brand applied for a new product in all equipment areas. It was written only in the Racket Covering Leaflet; therefore, this requirement is adopted for all Manuals.*
- b) This policy has been used for the past years when a brand applied for a new product in racket coverings.*
- c) There is a need to protect the customer from misleading information of the market.*

2.5.4. COLOUR/GLOSS, FINISH AND LINES OF TABLETOP

In addition to the principal finish, the playing surface must be marked with ~~white~~ side-lines, end lines and centre-lines (b6, b7, l7 and l8). The difference in level of all lines should not be detectable by the fingers, and in no case shall it be measurable. The lines must be clearly distinguishable from the colour of the playing surface, meeting the following request:

Side-lines / centre-lines	
Contrast Ratio between lines and playing surface	Specific clarification will be researched and be provided at the next ITTF Council

Provisionally, manufacturers are directed to use these contrast colours for table lines. The testing laboratories will survey the colours that are produced.

Brands that apply for another coloured line than white need to apply for a net assembly with a net tape in the same colour.

Rationale:

Lines on tables should have specific contrasting colours to the tabletop.

A new table side line colour requires a suitable net assembly with the same net tape colour, based on the new ITTF Statutes regulation 3.2.1.6, if it will be used in international competitions.

Provisionally, manufacturers are directed to use these contrast colours for table lines. The testing laboratories will survey the colours that are produced.

Brands that apply for another coloured line than white need to apply for a net assembly with a net tape in the same colour.

Rationale:

Net tapes of the net assemblies have specific contrasting colours to the net (mesh).

A new net tape colour requires a suitable table with same side line colour, based on the new ITTF Statutes regulation 3.2.1.6, if it will be used in international competitions.

M3 BALL – STANDARDS 2.6 – Stamp/ Second stamp**SECOND STAMP**

For designated events, the ITTF may allow a second stamp to be applied on balls which are already ITTF approved and will be used only in that event. In this case, the second stamp shall be antipodal to the first one. The permission to print a second stamp and the design of the second stamp and the packaging shall be individually authorized by the ITTF.

Based on the sponsorship agreement, the wording used on each packing unit shall contain clearly which competition or series it applies to. The wording used on the packing may not contain false claims.

1. Olympic and Paralympic Games

Permission of the sale of the balls with a second stamp, and the permission of the relative marketing advertisements on the packaging are subject to the decision of the International Olympic Committee.

2. WTTC, WTT Series, WTT Feeder Events, Youth Series

The sales of balls with a second stamp are allowed until one year after the event or until the end of the sponsorship contract, whichever is the later date.

The sponsorship may be mentioned on the packaging of the balls beyond this date, but only by stating the year in which event took place.

Rationale:

The M3 has already provided the opportunity for the Brands to apply a second stamp on balls which are already ITTF approved and will be used only in designated events. In order to ensure equal treatment, it became necessary to define which competitions this rule applies to and what are the opportunities for selling these balls with two stamps.

During the ITTF Council Meeting, on the request of the ETTU President, the Equipment Chair proposed the amendment in blue highlight to remove the proposed point 3 on Continental Championships. The proposition was voted as amended.

COLOUR

Rationale:

From 2021, in addition to the 2 basic colours (red and black), we accept 4 more colours as follows:

- *Green*
- *Blue*
- *Purple/Pink*
- *Violet*
-

We would like to remove “Purple” and name this category only “Pink”. Without changing the standards (values), only the name would be changed. Several users have indicated that this name is confusing, as purple and violet colours are very close in range of the colours. In contrast, pink and purple are farther apart, so it would be better to leave only the “Pink” one.

This would also make the situation easier for our customers.

~~For floors with an identical surface but with different layers below may keep the same name if its different structure does not confer to the floor properties that are significantly different;~~ **The brand is allowed to apply for additional surface colours for one flooring product under the same name,** the ITTF may decide case by case and may therefore initiate testing.

Rationale:

There are no arguments to allow only 2 colours for one flooring product under the same name. A colour change should not change the playing properties. The ITTF Equipment department has the capacity to test the colour changes and to ensure the quality, that the playing properties will not change.

Thickness change of flooring layers lead to a property change and requires always a separated approval with a new product name.

- The sixth quota will be allocated to the highest ranked not-yet qualified team from the ITTF Table Tennis Teams World Ranking of October 2023, the month after completing the five Continental Championships.

The limited calendar dates available and other key reasons were the base for the proposal to skip the Intercontinental Stage.

Busan 2024 World Team Table Tennis Championships Finals – Playing System

OBJECTIVE

This document presents two options for the Busan 2024 World Team Table Tennis Championships Finals Playing System (WTTTC Finals).

INTRODUCTION

ITTF Technical Commissioner, Graeme Ireland, and ITTF Group Sports Director, Mikael Andersson, have considered that with the WTTTC Finals Busan 2024 being determinant to up to 50% of the quotas for the Paris 2024 Olympic Games in teams, this factor should be weighed into the decision of the Busan 2024 WTTTC Finals.

Following the review by the Continental Council, this report presents the basic structure of the event, including the bulk of the two proposed scheduling options, noting that both will remain acceptable, regardless of the chosen playing system.

RESPONSIBILITY

It is the responsibility of the ITTF Council to decide the system of play for the WTTTC Finals Busan 2024 on the recommendation of the Continental Council.

In the following pages, you will see the two options proposed, named Option A, and Option B.

PROPOSED FORMAT OF PLAY

PROPOSITION IC-2023-21 – OPTION B PASSED

Option A – 40 teams / Eight groups of five: Two teams advance to the main draw 1/16. The winners of the groups are drawn vs runners up in the knockout stage.

Facts to consider:

- Evaluated⁷ by ITTF Group's marketing team as the preferred option with slightly better commercial opportunities by expanding the TV options for the round of 16 matches.
- Favourable scheduling scenarios with one match per day/team, as the basic principle.
- Initial ranking and seeding become more important.
- Twenty-four out of forty teams are eliminated in the group stage.

Option B – 40 teams / Eight groups of five: Three teams advance to the main draw. Teams placed 2 and 3 in each group will play in the first round of the knockout stage, and the winners will progress to the round of 1/8, where they will face the group winners of the groups.

Facts to consider:

- Evaluated as most fair (sports/technical) system to be used, especially given the Olympic Qualifier scenario and certain immaturities connected to the new ITTF World Team Ranking – (WTTTC Finals 2024 used as Olympic Qualifier).
- More teams advance, adding eight competitive and important team matches to the main draw (4 MT+ 4WT round of 1/24). Added commercial value for data right sales.
- Should stimulate the competitiveness in the group stage. Winners of the group now with a bye in the first round of the knock-out stage.
- Sixteen out of forty teams eliminated in the group stage.

In the following pages, you will see the detailed format for each of the two proposed Systems of Play.

3.1.4 Teams ranked 17 – 40 shall be drawn similarly four-by-four using the modified snake system until all groups are complete.

3.2 The WTR which will be used for the for the draws shall be the last WTR before the draw.

2.1 The playing system will be as follows:

2.1.1 Each group of 5 teams shall play a complete round robin competition (4 matches per team).

2.1.2 The order of play and the scheduling of the matches will be prepared in such a way as to avoid, whenever possible, the possibility of “predetermining” results. All final round matches must be significant for each competing team.

2.1.3 Following the completion of the round robin in each group, a single knockout will be played with the top 3 teams in each group progressing to the knockout phase (24 teams).

2.1.4 The winners of each group (8 teams) will be drawn into seeded positions - winner of Group 1 seeded 1st (position 1), winner of Group 2 seeded 2nd (position 32), winners of Groups 3 and 4 drawn into positions 16 and 17, winners of groups 5, 6, 7 and 8 drawn into position 8, 9, 24, 25. Each team will receive a bye.

2.1.5 The teams placing 2nd in the group shall be drawn into the opposite half of the respective group winners, and face a 3rd placed team in the round of 32 with the restriction that teams having played against each other in the group stage, shall not meet again in the first round of the knock-out competition.

2.1.6 The winning team shall receive gold medals, the runner-up silver medals and the two losing semi-finalists bronze medals.

3. SEEDING AND RANKING

3.1 Seeding shall be done as follows:

3.1.1 Teams ranked 1 to 8 shall be seeded as top of each group in number order.

3.1.2 Teams ranked 9 – 12 shall be drawn in Groups 5 – 8.

3.1.3 Teams ranked 13 - 16 shall be drawn in Groups 1 - 4, etc.

3.1.4 Teams ranked 17 – 40 shall be drawn similarly four-by-four using the modified snake system until all groups are complete.

Paris 2024 Paralympic Games – Playing System

OBJECTIVE

This document presents the proposed Playing System for the Paris 2024 Paralympic Games.

INTRODUCTION

The International Paralympic Committee did approve in March 2023 the 31 events to be included in the Paris 2024 Paralympic Programme. This includes a total of 21 Singles Events (11 Men's Singles, 10 Women's Singles) and 10 Doubles Events (4 Men's Doubles Events, 4 Women's Doubles Events, and 2 Mixed Doubles Events), being one of the first sports to have introduced Mixed Events at the Paralympic Games.

With 280 athletes and the above-mentioned 31 events, Para Table Tennis is the third sport with more athlete quotas and the fourth with more Medal Events in the Summer Paralympic Games Programme.

RESPONSIBILITY

It is the responsibility of the ITTF Council to decide the system of play for the Paris 2024 Paralympic Games on the recommendation of the Continental Council.

PROPOSED FORMAT OF PLAY

The following playing formats are recommended for the Paris 2024 Paralympic Games:

Seeding and Draw system

The August 2024 World Rankings shall be used for seeding:

- Draws in single events will use the ITTF World Para Table Tennis Singles Ranking lists
- Draws in doubles events will use the ITTF World Para Table Tennis Doubles Ranking list (the ranking points of a pair will be the sum of the doubles ranking points of each individual player)
- Draws in mixed doubles events will use the ITTF World Para Table Tennis Mixed Doubles Ranking lists (the ranking points of a pair will be the sum of the mixed doubles ranking points of each individual player).

The draws for all events are conducted as follows:

PROPOSITION IC-2023-22 – PASSED

- All singles and doubles events will follow a direct elimination format.
- In each event, there will be a maximum of two players/pairs from any one NPC.
- In all knock-out competitions with up to 16 players, the player/pair seeded one is placed into position 1, and the player/pair seeded two is placed into position 16. The players/pairs ranked 3 and 4 are drawn into positions 8 and 9; the players/pairs ranked 5, 6, 7 and 8 are drawn into positions 4, 5, 12 and 13.
- In the knock-out competitions of more than 16 players, the player/pair seeded one is placed into position 1, and the player/pair seeded two is placed into position 32. The players/pairs ranked 3 and 4 are drawn into positions 16 and 17; the players/pairs ranked 5, 6, 7 and 8 are drawn into positions 8, 9, 24 and 25; the players/pairs ranked 9 to 16 are drawn into positions 4, 5, 12, 13, 20, 21, 28 and 29.
- In all cases, byes are distributed as evenly as possible throughout the first round, being placed first against seeded places, in seeding blocks order.
- If there are 9, 10, 11, or 12 players/pairs, the remaining players/pairs are drawn into positions 3, 6, 11 and 14
- If there are 13 players/pairs, the remaining 5-6 players/pairs are drawn into positions 3, 6, 7, 10, 11 or 14; with the bye going to either position seven or position ten
- If there are 14 players/pairs, the remaining six players/pairs are drawn into positions 3, 6, 7, 10, 11 or 14
- If there are more than 16 players/pairs in any event, the players/pairs ranked 17-24 will be drawn as evenly as possible throughout the first round against players/pairs ranked 9-16.
- In all draws, players/pairs from the same NPC must be drawn into opposite halves of the draw.
- During the draw, the referee will ensure the draw actions are presented to allow OC Technology (OVR) to capture the actions as they occur.

Recommendations – Summary – Singles and Doubles Events

- To apply the straight knock-out system for Paris 2024 Paralympic Games
- To use seeding protection
- To use separation by NPC – two athletes of the same NPC must be drawn into opposite halves.
