ANNUAL GENERAL MEETING

Draft of the MINUTES of the Annual General Meeting of the International Table Tennis Federation held at the Sheraton Hotel, Doha, Qatar, in a hybrid format on Tuesday, 27 May 2025, starting at 10:00 AST (07:00 UTC), with an Online Continuation held on 15 November 2025, starting at 18:30 SGT (10:30 UTC)¹.

1. President's Welcome and Opening Address

The President, Ms Petra SÖRLING, opened the meeting by welcoming His Excellency Mr Jassim bin Rashid AL-BUENAIN, Secretary General of the Qatar Olympic Committee, along with the delegates representing the Member Associations and the Executive Board. She expressed the ITTF's sincere appreciation to the Qatar Table Tennis Association for the successful delivery of the 2025 World Championships Finals and the concurrent ITTF Summit in Doha. The President defined the Annual General Meeting (**AGM**) as the ITTF's most critical moment of accountability, comparing it to an annual performance review or yearly examination in which the leadership must demonstrate results and reaffirm the core values of integrity and exemplary leadership.

Reflecting on the 2024 AGM in Busan, where she anticipated exponential progress, the President stated that the results achieved over the subsequent 15 months speak for themselves, with unprecedented growth and vibrancy in the sport. Ms SÖRLING highlighted that global reach has expanded significantly and the ITTF's business is blossoming, with players and Member Associations now placed firmly at the centre of all actions. The President emphasised that these successes were the product of vision and carefully planned strategies rather than accident, and she expressed her gratitude to the Executive Board and the ITTF staff for turning these ambitions into tangible achievements for the next generation. In closing, Ms SÖRLING wished all delegates a successful meeting and formally handed the floor to the host representatives for their opening remarks.

2. Guest of Honour Opening Address

H.E. Jassim bin Rashid AL-BUENAIN, Secretary General of the Qatar Olympic Committee and Vice President of the Organising Committee of the World Table Tennis Championships Finals

– Doha 2025 (**WTTC**), welcomed the delegates to the State of Qatar and expressed his pleasure in hosting the AGM following the successful delivery of the WTTC. He described the championships as an inspiring week that brought together elite athletes and served as a celebration of unity, fair play, and mutual respect. He stated his firm belief that the defining moments in sport are shaped not only on the field of play but also in crucial meetings like the AGM, which provide a platform to discuss the present and future of the game for generations to come.

Mr AL-BUENAIN further noted that the AGM represented a milestone for open engagement and reflected the integrity upheld by the ITTF, particularly regarding the day's elections. He reaffirmed the commitment of the Local Organising Committee (**LOC**) and the Qatar Olympic Committee (**QOC**) to providing an ideal environment for fruitful discussions and a fair election process organised to the highest standards. Highlighting Qatar's role as a dynamic and active partner in the global sporting movement, Mr AL-BUENAIN stressed the importance of advancing sport governance and promoting international cooperation. In closing, he wished the delegates a productive meeting and successful elections, expressing hope that their decisions would serve the future of the sport and meet the ambitions of athletes and fans worldwide.

3. Host Welcome and Opening Address²

4. 2024 in Review

4.1 Olympic and Paralympic Games Update³

Mr Bart VERMOESEN, Event Director, made a presentation on the Olympic and Paralympic Games Update on section 12.3.

4.2 World Cups Update

Ms Nicole CHEN and Mr Mounir BESSAH presented an update on the revitalisation of the ITTF World Cups. They detailed the successful introduction of a new playing system for the Mixed Team World Cup in Chengdu and emphasised a player-centric approach that ensures all participants receive prize money and free accommodation to perform in optimal conditions. The AGM noted the significant advancements in event presentation, including the use of the TTR (Table Tennis Review) system. The AGM noted the strategic focus on the younger generation, achieved through high-production entertainment shows, modern branding, and expansive outreach, including cinema screenings in 10 cities in China and interactive digital platforms featuring former champions engaging with fans online.

The report celebrated record-breaking engagement figures, with 400,000 on-site spectators and venues in Macau and Chengdu consistently reaching full capacity, with tickets often selling out in minutes. The presentation further explored the successful integration of localised cultural elements and sustainable practices, such as the reuse of event infrastructure and the promotion of green transport initiatives for fans. In outlining the future of the property, the presenters announced plans to develop a World Cup series across continental and regional levels to ensure that the success of the marquee events benefits the entire membership. To support this global expansion, participation in the World Cup has been increased to 48 players, with guaranteed continental spots to ensure a diverse and representative field of elite talent from every region.

To conclude this section, Ms SÖRLING reflected on the importance of having the World Cups back and thanked those who worked for such a return.

4.3 World Table Tennis Update

Ms Tessa CHO and Mr Johnny COWAN presented a comprehensive update on World Table Tennis (WTT), characterising 2024 as a landmark year defined by "great momentum" and strategic success. They reported that the professional circuit has successfully expanded into all continents, highlighted by a historic return to Beijing for a major international event for the first time in over sixty years. A central pillar of the 2024 strategy was the utilisation of significantly larger venues in cities such as Chongqing, Shenzhen, and Macau, which allowed the sport to reach record-breaking attendance levels. This shift, described as "*sportainment*," has focused on enhancing the fan experience through high-quality production and music to ignite global passion for the game.

The presentation highlighted a major financial milestone: WTT turned a profit in 2024, marking a successful return on the significant investments made since the entity's inception. This financial stabilisation has directly benefited the athletes, with record prize money of over 11 million USD distributed in 2024, nearly a threefold increase from pre-pandemic levels. The AGM noted that WTT has built a global platform that allows players to shine as premium sports stars while integrating resources across broadcast, marketing, and partnerships to grow the entire table tennis ecosystem.

The report further explored a unique shift in fan demographics, noting that table tennis now enjoys a particularly strong following among young women under 35, a demographic unique among international sports. This fresh brand look has allowed the sport to break into new markets and position table tennis as a premier global property. In closing, the presenters emphasised that WTT is dedicated to creating stars and defining the future of the game, with expectations for 2025 to be even bigger, driven by an expanded calendar of events and continued commercial growth.

4.4 ITTF Foundation Update

Mr Leandro OLVECH presented an update on the ITTF Foundation, reaffirming its core vision of "Table Tennis for All for a Better Life". He reported record-breaking participation in the 11th edition of World Table Tennis Day in 2025, with 844 celebrations across 146 countries focused on the themes of diversity and inclusion, as in 2024. The AGM noted the expansion of the Dream Building Fund to 20 community projects worldwide, highlighting a specific collaboration with the Somali Table Tennis Association and the University of New York to protect youth at risk of recruitment into armed conflict through sport.

The presentation further detailed the growth of the World Table Tennis for Health Festival, held in 2024 in Maizières-lès-Metz, France, which successfully brought together the World Parkinson's and World Alzheimer's Table Tennis Championships alongside the World Table Tennis for Health Congress. Mr OLVECH introduced the new [NeuroPong Handbook](#), a practical resource designed to assist coaches and associations in working with players affected by neurodegenerative diseases. The AGM also noted the [ITTF Foundation Annual Report for 2024](#) activities, highlighted the integration of the Foundation's mission into major events, such as the representation of Parkinson's players at the World Masters in Rome, and recognised Ultimate Table Tennis as the main sponsor of the World Table Tennis for Health Festival. In closing, it was announced that the next edition of the festival would be hosted in 2025 in Helsingborg, Sweden, as the Foundation continues to scale its social impact through the sport.

4.5 ITTF Development Update

Ms Yelena DRUZHKOVA and Mr Mikael ANDERSSON presented an update on ITTF Development, highlighting the diverse range of programs and projects offered to Member Associations across all continents. The presentation detailed the support provided through continental Youth and Para training camps, as well as the impact of specialised youth and Para

grants for athletes. A significant milestone was reported in gender equity, with female participation rising to 42% across all development activities, a success largely attributed to the "My Gender, My Strength" program. The AGM further noted the expansion of educational activities, including mentorship for coaches and match officials, as well as workshops for competition managers.

The report outlined several key initiatives for the coming years, including the development of a new coach certification and licensing system to be implemented in 2027 and 2028. The department is also focusing on preparing the federation for AI integration into sports education and launching new regional team competitions to support the development of the regions.

Significant emphasis was placed on the Dakar 2026 Youth Olympic Games (**YOG**), with the presenters recognising the "fantastic talent pool" currently emerging from Africa and the IOC's implementation of an invitation system for the YOG. In closing, Member Associations were invited to actively engage with these programs to ensure that development remains a central pillar of the ITTF's mission.

5. Recognitions

The following recognitions were made at the AGM:

- 5.1 To the Korean Table Tennis Association (KOR), for the World Team Table Tennis Championships Finals, and ITTF Summit, Busan 2024.
- 5.2 To the Macao Table Tennis Association (MAC), for the ITTF Men's and Women's World Cup 2024.
- 5.3 To the Italian Table Tennis Federation (ITA), for the World Masters Championships, Rome 2024.
- 5.4 To the Swedish Table Tennis Association (SWE), for the ITTF World Youth Table Tennis Championships and ITTF Youth Development Summit, Helsingborg 2024.
- 5.5 To the Swedish Table Tennis Association (SWE), for the ITTF World Esports Table Tennis Championships and ITTF Esports Summit 2024, Helsingborg 2024.
- 5.6 To the Chinese Table Tennis Association (CHN) for the Mixed Team World Cup, Chengdu 2024.
- 5.7 To the French Table Tennis Federation (FRA) for the Paris 2024 Olympic and Paralympic Games 2024.
- 5.8 To the Singapore Table Tennis Association (SIN) for the Singapore Smash 2024.
- 5.9 To the Saudi Table Tennis Association (KSA) for the Saudi Smash 2024.
- 5.10 To the Chinese Table Tennis Association (CHN) for the China Smash 2024.
- 5.11 To Table Tennis New Zealand (NZL) as the most active Member Association in 2024.
- 5.12 To Mr LEI Zhenjiang, for his outstanding contribution to the sport of table tennis.
- 5.13 To the Qatar Olympic Committee (QOC) and the Qatar Table Tennis Association (QTTA) for the outstanding organisation of the Sport Science Congress, the World Table Tennis Championships Finals, and the ITTF Summit, Doha 2025.

6. Roll Call of Associations Present (Confirmation of registered Associations)

The Secretary General, Mr Raul CALIN, proceeded with the Roll Call of [registered associations](#), with the technical assistance of LUMI, the third-party voting solution provider. LUMI representative Mr Matthew RYDER confirmed that a total of 201 Member Associations were present at that point in the AGM, with 185 Associations physically present and another 16 joining online. Mr CALIN complemented Mr RYDER's information, indicating that a maximum of 208 Member Associations could potentially take part if all those registered join the AGM⁴.

7. Appointment of a Chair

Mr Graham SYMONS, ITTF Executive Vice-President, who is not running for any position at the 2025 elections, was nominated by the EB as the AGM Chair.

Before proceeding with the vote on the Appointment of a Chair, Mr Abdulla AL-MULLA, Chair of the Nominations Committee, asked for clarification about the test vote displaying 202 votes, instead of the 201 initially mentioned by Mr RYDER. Mr CALIN confirmed that, as already mentioned during the [roll call](#), the total number of Member Associations (**MA**s) taking part in the AGM could increase to 208 if all registered MAs attend, with 201 representing those MAs present at the time of the roll call.

2025-05-27-AGM-01 (simple majority required)

The AGM accepted Mr Graham SYMONS's nomination as the 2025 ITTF AGM Chair.

194 valid votes. 142 votes in favour. 40 votes against. 78.02 % in favour (12 abstentions).

8. Confirmation of the Agenda

The Agenda was confirmed without any further additions.

9. Appointment of Scrutineers

The AGM noted that, as in previous years, LUMI® would provide the technical solution for electronic voting, with Mr Matthew RYDER and Mr Mark JACKSON as operators. The following individuals were proposed by their respective Continental Federations as Scrutineers:

193 valid votes. 182 votes in favour. 5 votes against. 97.33 % in favour (6 abstentions).

10. Confirmation of the Minutes of the AGM held on 27th February 2024 in Busan, Republic of Korea.

With no remarks on the 2024 draft Minutes, the AGM proceeded to vote.

2025-05-27-AGM-03 (simple majority required)

The AGM adopted the 2024 AGM Minutes as a true record.

195 valid votes. 160 votes in favour. 5 votes against. 96.97 % in favour (30 abstentions).

11. Membership

The Secretary General reported on the membership case concerning Indonesia, involving a joint proposal from the Asian Table Tennis Union (ATTU) and the ITTF to expel the current MA and accept a new member. It was noted that the President of the current Indonesian MA and the Secretary General of the National Olympic Committee of Indonesia had been invited to express their views during the consideration of the specific proposition later in the agenda. Beyond this case, Mr CALIN informed the AGM about several MAs governance issues throughout 2024 and early 2025, noting that some had been resolved while others remained ongoing. The Secretariat expressed hope that the proposed resolution for a new constitution in 2026 would make the review of membership status more dynamic, as current processes often take several years to resolve.

During the discussion, Mr Andrew MUDIBO (KEN) questioned the necessity of the AGM listening to representatives from Indonesia and the National Olympic Committee if the Executive Board had already debated the matter and reached a recommendation. The Secretary General clarified that the ITTF Constitution explicitly grants any Member Association facing a proposal for suspension or expulsion the right to be heard at the Annual General Meeting. Mr CALIN emphasised that the ITTF must respect these constitutional obligations by allowing the representatives of the existing association to speak before the AGM takes a final vote.

12. Other Presentations

The AGM noted the presentation “In Memoriam” of the table tennis personalities who had passed away since the last AGM held in Busan in February 2024, with a commemorative video.

12.1 London 2026

Mr Richard SCRUTON, Chair of the Organising Board of the ITTF World Team Table Tennis Championships Finals London 2026 (**WTTC**), and Ms Sally LOCKER (CEO of Table Tennis England) provided an update on the WTTC preparations, emphasising that the event marks the ITTF's centenary by returning to the city where the first championships were held in 1926.

The presenters confirmed the dates 28 April to 10 May 2026 for the event, which will feature an expanded competition format to accommodate 64 men's and 64 women's teams. The presentation detailed the use of two iconic primary venues, the Copper Box Arena and Wembley Arena, both recognised for their high spectator capacities and prior success in hosting major international competitions.

A significant focus of the presentation was sustainability and delegate convenience, noting that five hotels are within a 15-minute walk of the Copper Box, and that a major hotel is located just 50 meters from Wembley Arena, which will minimise transportation requirements. The organisers confirmed that the UK government is supporting a streamlined visa process, and a dedicated guide will be issued to member associations to ensure timely applications. The AGM further noted the launch of the "Learn with London" sustainability initiative and a five-year legacy plan designed to transform table tennis into a premier sport in England and engage the next generation as the sport enters its second century.

12.2 Innovations / Esports

ITTF CEO, Mr Steve DAINTON, presented a comprehensive update on Innovations and Esports, highlighting the ITTF's commitment to integrating new technologies and AI across the group's activities. A central focus of the report was the Table Tennis Review (TTR) system, which, after initial trials in 2019 and further testing in 2024, was fully implemented at the 2025 Men's and Women's World Cup in Macau and the WTTC in Doha. The AGM noted that TTR allows players to challenge umpiring decisions on questions of fact, particularly regarding the service rule and edge balls, thereby enhancing the fairness of the sport while adding a layer of drama for spectators. Mr DAINTON reported that feedback from athletes has been overwhelmingly positive and announced plans to progressively introduce TTR at all major events, including Grand Smashes and the Mixed Team World Cup.

The presentation further detailed the success of the inaugural ITTF World Esports Table Tennis Championships held in Helsingborg in 2024, which marked the sport's official entry into the digital arena. Building on this momentum and the International Olympic Committee's launch of the Esports Games, the ITTF announced the signing of a Memorandum of Understanding with the Saudi Table Tennis Federation (**STTF**) to explore hosting the next edition of the World Esports Championships in that country. Prince Mohamed AL SAUD, President of STTF, addressed the AGM to express his enthusiasm for the partnership and invited the table tennis family to experience a future-focused tournament that effectively blends traditional sport with immersive digital interaction.

12.3 Los Angeles 2028

The Secretary General introduced Mr Bart VERMOESEN, new ITTF Event Director as of 15 April 2025, adding that Mr Mohamed DAWLATLY has also been promoted to the position of Head of Events, and indicating that Mr VERMOESEN will present on both Paris 2024 and LA28.

Mr VERMOESEN reported on the record-breaking engagement and overbooked venues at the Paris 2024 Olympic Games, categorising the table tennis events as "best ever". The AGM noted the recent announcement by the IOC that table tennis will feature a historic six-medal event program at the LA28 Games. The presentation detailed the sport's Olympic growth from its four-event model (1988–2016) to the unprecedented six-event structure secured for Los Angeles.

The AGM noted the continued strength of table tennis at the Paris 2024 Paralympic Games, which had the 3rd-highest broadcast airtime among all sports, featuring 31 medal events.

Mr VERMOESEN expressed appreciation to the organisers, equipment suppliers, and the ITTF family for their role in expanding the sport's Olympic and Paralympic footprint.

13. Annual General Report & Strategic Plan (SP)

13.1 ITTF Group CEO

The ITTF Group CEO, Mr Steve DAINTON, referred to the different reports already presented at the AGM and expressed his sincere appreciation to the management team for their hard work, including the Olympic Games, World Cups, World Table Tennis, the ITTF Foundation, and Development. Reflecting on his nearly eight-year tenure as CEO, Mr DAINTON characterised the past 12 months as the most successful period of his career in table tennis, emphasising unprecedented momentum worldwide.

Mr DAINTON thanked the ITTF Executive Board (**EB**) for their trust and commended the management staff for the tireless hours dedicated to achieving these results. He noted that the progress achieved would be further illustrated during the financial report and reaffirmed the commitment to the ongoing implementation of the ITTF Strategic Plan. To conclude, he informed the AGM that an updated version of the plan would be provided online following the meeting, featuring specific measurements and tracking tools to monitor the Federation's progress toward its strategic objectives.

14. Finance

Mr SYMONS gave the floor to the EVP Finance, Dr Alaa MESHREF, who had no further comments on his report, thereby inviting Mr Michael BROWN, ITTF Chief Financial Officer (CFO), and Mr Andrea COSTA, PwC Auditor, to provide an update on the different items of this section. Dr MESHREF took the opportunity to thank Mr Andreas COSTA for all his support and advice during the auditing process.

14.1 Report of the Audit and Finance Committee

The Audit and Finance Committee report, included in the [AGM Working Documents](#)⁵ package, was noted.

14.2 Financial Report

Mr BROWN referred to the Finance Forum⁶ held on Friday, 23rd May 2025, at which a more detailed presentation was given on the 2023 and 2024 finances.

14.3 2023 Audited Financial Statements (AFS)

Mr Michael BROWN presented the [2023 Audited Financial Statements](#), characterising the year as a period of significant difficulty for the ITTF Group. He reported that the consolidated balance sheet's overall value at the end of 2023 was approximately \$38.3 million, though the Federation faced major liquidity challenges because current liabilities were significantly greater than current assets. This financial position was largely a result of the ITTF's efforts to manage and ensure the repayment of various debts incurred during the challenging recovery period following the COVID-19 pandemic.

Regarding the income statement, Mr BROWN explained that while management attempted to maintain the growth momentum seen after the reopening of international borders, a combination of factors, both within and outside the Federation's control, led to a substantial bottom-line loss of \$9 million USD for the 2023 financial year. He noted that while 2023 was an exceptionally difficult period, the subsequent 2024 financial performance demonstrated a transition toward stability and success across the ITTF, World Table Tennis (WTT), and the ITTF Foundation.

14.4 2024 Audited Financial Statements (AFS)

Mr Michael BROWN presented the [2024 Audited Financial Statements](#), highlighting a significant improvement in the Federation's financial position and stability. He reported that cash and cash equivalents surged from less than \$500,000 at the end of 2023 to over \$13 million by the end of 2024, with current assets now approaching the level of current liabilities, marking a much more stable position than twelve months prior.

Mr BROWN detailed a substantial growth in revenue, attributed to increased event frequency, record fan attendance, and expanded global broadcast reach. He further explained that strategic measures taken in 2023 resulted in notable reductions in general, administrative, governance, and regulatory expenses throughout 2024. Mr BROWN emphasised that the ITTF views its expenses as direct investments back into the sport and announced that 2024 marked the Federation's first profitable year since 2018. He noted that the losses incurred during the preceding five years were part of a planned journey to establish and grow World Table Tennis (WTT).

Following his remarks, he introduced the external auditor, Mr Andrea COSTA, to provide a formal presentation on the audit findings.

Mr Andrea COSTA, Director at PwC Switzerland, presented the independent auditor's report on the ITTF Group consolidated financial statements for the years 2023 and 2024. He explained that the audit was conducted using a risk-based strategy, specifically focusing on high-risk areas such as revenue and income recognition, trade receivables, contract assets, and the recoverability of value-in-kind contributions.

Mr COSTA confirmed that the 2023 and 2024 audit reports presented no qualifications or remarks, and he verified that the financial statements were prepared in accordance with Swiss law. Furthermore, as part of statutory duties in Switzerland, he confirmed the existence and effectiveness of internal controls over financial reporting, noting that management had implemented necessary procedures across business processes and cycles. Based on these positive conclusions, he formally recommended the financial statements for approval by the AGM.

Following the interventions⁷ of Mr Robert JJAGWE, Delegate of UGA, Mr Fessou LAWSON-GAIZER, Delegate of TOG, and Mr George KOPALY, ITTF Council Member from Lebanon, and the responses of Mr BROWN and Mr COSTA, the AGM Chair, Mr Graham SYMONS, moved to the vote for approval of the 2023 and 2024 Audited Financial Statements.

14.5 2025-2028 Quadrennial Forecast

Mr Michael BROWN presented the 2025-2028 Quadrennial Forecast, noting that the projections served as an update to the forecast first presented at the 2024 AGM in Busan. He highlighted the sport's positive state across its events, fan engagement, and broadcast reach. The AGM noted a forecast of an additional \$10 million US in revenue in 2025 (based on a full calendar of events), and a forecast of 2.8 million in ITTF project expenses, representing approximately 22% of total ITTF revenue, dedicated to development, continental support and education.

Looking ahead, the forecast projects a consistent 3% to 4% year-on-year growth through 2028. Mr BROWN described this as a "prudent approach" based on the assumption of "business as usual", while acknowledging that strategic innovation tasks currently underway could potentially drive growth beyond these estimates. Compared to the budget approved in the previous year, the updated forecast reflects a modest improvement in the Federation's bottom-line performance.

Following the [intervention of Mr Wolfgang DOERNER](#), Delegate of GER, and the response from Mr BROWN, the AGM Chair, Mr Graham SYMONS moved to a vote on the approval of the 2025-2028 Quadrennial Forecast.

At this point, Mr Abdulla AL-MULLA, Chair of the Nominations Committee (**NC**), [took the floor](#), expressing concern regarding the prioritisation of the use of funds within the ITTF. He highlighted a specific case brought against him concerning the mismanagement of the NC. Mr AL-MULLA noted that the ITTF Tribunal eventually dismissed the charges, but he questioned why the ITTF had to bear the legal costs—including a 5,000 Swiss Franc contribution to his legal fees—rather than the individual complainants. He stated that the investigation had unfairly tarnished his 45-year reputation and reflected poor decision-making by those pursuing the action.

[In response, Mr Enric RIPOLL \(Chair of the Integrity Board\) explained](#) that the Integrity Unit is constitutionally required to investigate every complaint received, provided it is not deemed frivolous or in bad faith. He clarified that a dismissal by the ITTF Tribunal does not mean the complainants acted in bad faith, but rather that the evidence collected did not meet the ITF Tribunal's threshold. He further noted that the Integrity Unit made the decision to proceed based on its legal assessment, which is why the Federation, not the complainants, was responsible for the costs.

[Mr Robert JJAGWE \(UGA\) raised concerns](#) about resource allocation, noting that the Integrity Unit's total budget is approximately \$250,000. He argued that development should be a higher priority than "chasing undisciplined people" and that the Integrity Unit sent more communications in the last three months than in the previous three years. [Mr RIPOLL countered](#) that more than half of the Unit's budget is dedicated to anti-doping management¹², including testing and education, and that individual integrity cases, particularly in the area of illegal betting, can be extremely expensive, costing between \$50,000 and \$75,000 each.

[Mr Kevin CARPENTER \(ITTF Head of Integrity\) addressed](#) the "communication surge" noted by Mr JJAGWE over the last few months, explaining that while the Unit must maintain strict confidentiality until cases are resolved, it should be obvious to everyone in the room that being an election period there are important alerts and reminders to be shared by the Integrity Unit (IU) with the membership. Mr CARPENTER detailed the resource challenges in his office, which consists only of himself and one part-time junior staff member, affecting the time required for case management. He reminded the Assembly that the Integrity Unit is not a law enforcement agency and must rely on the cooperation and reporting obligations of Member Associations.

Finally, following [comments from Mr Emad HUSSAIN](#) (IRQ) regarding the need to focus on "real things" like sexual harassment, and [Mr KOPALY's comment](#) about the leaking of information, [Mr CARPENTER strongly defended](#) the unit's work and denied any leaks of confidential information from the IU. Furthermore, Mr CARPENTER highlighted the recent 10-year ban of a coach for sexual assault as a primary example of the Unit's effectiveness in protecting victims, witnesses, and the integrity of the sport.

Before the voting for Executive Vice-Presidents could proceed, the AGM was disrupted by unauthorised interventions by several persons. Despite the attempts to continue the proceedings, and once it was clear that the disruptors would not allow the democratic process to continue, the AGM Chair, Mr Graham SYMONS, had no other option but to suspend the AGM.¹⁸

Online Continuation of the 2025 ITTF Annual General Meeting held on 15 November 2025, starting at 18:30 SGT (10:30 UTC)

The Chair, Mr Graham SYMONS, formally opened the Continuation of the 2025 ITTF Annual General Meeting, convened in a fully online format in accordance with the ITTF Statutes and the Executive Board's decision of 20 September 2025. He confirmed that the continuation had been duly notified to all Member Associations and that all procedural requirements under Articles 1.41, 1.61.1.16, and 1.61.1.17 of the ITTF Statutes had been fulfilled. The Chair explained that the session's purpose was to complete the pending items from the AGM session initiated in Doha on 27 May 2025, including the election of ITTF Executive Vice-Presidents, the ratification of Council Members, the Appointment of Committee Members, and the ITTF Centenary preparations for 2026.

LUMI representatives confirmed that 165 voting delegates were present at the start of the meeting, out of a total of 207 Member Associations registered and entitled to vote¹⁹. The Chair reminded delegates that each association held one vote, to be conducted electronically via the secure LUMI system, noting that the number of present delegates might fluctuate throughout the session.

In his concluding remarks, the Chair emphasised the ethical obligations of all table tennis parties under Article 6.2 of the ITTF Code of Ethics. He urged all delegates to use due care and diligence, acting with the highest degree of integrity, impartiality, objectivity, and professionalism. He specifically reminded the AGM of the prohibitions against acts likely to cause disrepute, defamatory statements, falsehoods, and the abuse of authority, stressing the general duties of neutrality and good faith governing the meeting's deliberations and votes.

The Secretary General introduced the staff members from LUMI, indicating that they would be joined online by the [scrutineers](#) appointed on the 27 May 2025 initial session of the AGM. Mr CALIN invited LUMI representatives to conduct a test vote for the delegates.

Before starting the voting for the ITTF Executive Vice-Presidents positions, [Mr Mohanad KABBANI, delegate of SYR, asked](#) about the verification process for delegates and the physical locations of the AGM Chair and Secretary General, indicating that if they were in Singapore, that would provide "procedural advantage"²⁰. He also asked about the Secretary General's contract and qualifications, and whether the Executive Committee²¹ had considered asking the Secretary General to resign.

[Mr SYMONS responded](#) that the reason for the Member Associations to be online while the persons in the table²² were in Singapore was merely logistical and in relation to the second question, Mr SYMONS informed that any Member Association with specific complaints or objections regarding the Doha meeting has the right to appeal or utilise established procedural processes to seek rectification. He noted that he was not aware of any such formal complaints having been filed and reiterated that the proper avenue for such concerns is through the ITTF's formal appeal mechanisms.

Prior to the election of the Executive Vice-Presidents, the Chair, Mr Graham SYMONS, noted that an updated report sent on behalf of the Nominations Committee regarding candidate eligibility had been made available to all Member Associations on 14 November 2025. He reported the committee's decision to declare Mr Alaor AZEVEDO (BRA) and Mr Imre KOVACSICS (HUN) ineligible to serve as candidates; however, the Nominations Committee determined that both individuals should remain on the ballot. The Chair clarified that, should either candidate be elected, the election would only take effect if a formal appeal against the Nominations Committee's decision was filed and subsequently upheld.

Mr SYMONS explained the procedure for voting on the eight vacant positions and the necessity for additional ballots if the number of candidates obtaining a simple majority is fewer than the number of vacancies.

Mr RYDER informed that, at this point, 179 delegates were joining the AGM and proceeded with the test vote.

During the test vote, the [delegate of COM asked](#) about the list of delegates and about how the voting would continue in case of not having elected all eight candidates.

Mr SYMONS responded, indicating that all 207 Associations listed in the roll call on the first session are eligible to participate. On the second question, Mr SYMONS explained that, depending on the result of the first round, subsequent rounds will be needed if there are fewer candidates with a simple majority than the number of vacancies, adding that the process will be explained at each stage.

Following her intervention, the ITTF Council Member, [Mr George KOPALY, asked](#) about the cost of the AGM Continuation, about the list of countries participating²³ and added that in a conversation with Mr Enric RIPOLL²⁴, Mr RIPOLL would have indicated to him that "*the Integrity Board could not investigate any complaint against the running president "being in the payroll of the ITTF"*". Furthermore, Mr KOPALY considered it inappropriate that [Mr Chris TAM could decide for himself](#) on the eligibility of candidates²⁵.

Mr SYMONS indicated he couldn't provide the cost of the AGM Continuation and added that the candidates' eligibility is not a matter for the AGM but for the Nominations Committee.

During the test vote, the number of delegates present rose to 181.

LUMI proceeded with the voting for the ITTF Executive Vice-Presidents.

During the five-minute voting window for the first round of voting a voting delegate joined the AGM for a total of 182.

26. Ratification of the ITTF Council Members

The AGM noted the nominations submitted by 27 Member Associations by the set deadline, which have been proposed for ratification by the respective continental federations and verified by the Nominations Committee.

Mr SYMONS proposed that, unless there were procedural objections, the vote would proceed as a single-block vote, with a single majority required.

At this point, [Mr AL-CHAAB Abbas, the first delegate of IRQ, asked](#) about the list of delegates present in the meeting. Mr SYMONS responded in line with his previous response to COM²⁶.

[Mr KABBANI asked](#) if LUMI representatives were in Singapore or somewhere else and added²⁷, *“Plus I just want to comment on Mr Graham, because I wasn’t able to comment based on your first um answering my question, and the question is you were saying that there is a procedure for um questioning the secretary general and so on. But we as a AGM I think we have the right to request that from the EB, and I think the most important thing is to reunify the ITTF, and I don’t think that this is will be happen if Mr Secretary General will remain in his position”*.

[Mr SYMONS referred his question to Mr Steve DAINTON](#), ITTF Group CEO, who stated that the CEO reports to the Executive Board and the Secretary General reports to the CEO, adding that there have been no decisions related to staff since the start of the AGM in Doha, and that for now, there are no reasons to make any adjustments either. Mr DAINTON added that he can take more questions after the meeting.

Mr SYMONS responded to the first question, indicating LUMI representatives were in Singapore.

Not having further questions at this point, Mr SYMONS asked LUMI representatives to open voting for the ratification of the ITTF Council Members.

[Mr Rudolf SPORRER took the floor](#), indicating that after 20 years in the position as Chair of the Rules Committee, it was already time for refreshment, hence the reason for him not to be a candidate anymore for the position of Chair, but being happy to be a corresponding member, to continue advising the Committee.

Mr SYMONS thanked Mr SPORRER for his service to the Rules Committee.

28. ITTF in 2026 – One Hundred Years

Mr SYMONS gave the floor to Mr DAINTON to present this agenda item.

Prior to the update on the ITTF Centenary, the ITTF Group CEO, [Mr Steve DAINTON, congratulated the newly elected and appointed officials](#), stating that for the ITTF to function effectively, it requires solid foundations and a fully united organisation. He expressed a strong hope for unity for the future of the sport.

Mr DAINTON extended his gratitude to LUMI for their professional execution of the voting process, emphasising that it is "totally impossible" for any ITTF staff or officials to infiltrate or manipulate the secure voting system. He highlighted the Secretary General, Mr Raul CALIN, noting his "unbelievable experience" in running AGMs and explaining why his presence was essential to the meeting.

He further thanked the staff for ensuring the meeting proceeded smoothly. In his concluding remarks, the CEO firmly dismissed various "conspiracy theories," asserting that all procedures were conducted with extreme professionalism, in strict accordance with the ITTF Constitution, and under the oversight of lawyers to maintain the highest standards, adding, "*I'm very proud of what ITTF has done here today*".

Back to the point of the Centenary, [Mr DAINTON provided an update on the ITTF Centenary](#) celebrations scheduled for 2026, marking 100 years since the Federation was established in London by its first president, Mr Ivor Montagu, in 1926. He introduced the new centenary logo, which will replace the standard ITTF logo throughout the commemorative year, along with a special-edition 100-year logo (1926–2026) intended for merchandise, gifts, and specific high-profile moments.

The AGM noted that the ITTF plans to celebrate this milestone at all marquee events and across every discipline, including elite, para, youth, esports, and recreational formats. Delegates were asked to "save the dates" for a centenary gala dinner in London on 2 May 2026, which will precede the 2026 Annual General Meeting on 3 May 2026.

Mr DAINTON emphasised the historical significance of returning to London, the site of the first World Table Tennis Championships, and concluded with a call for the Federation to remain "united as one" to make the centenary the most successful year in the sport's history.

29. Next General Meeting

The AGM noted that the 2026 ITTF AGM will be held in London, England, during the 2026 World Team Table Tennis Championships Finals, with logistical arrangements to be confirmed in due course.

30. Any Other Business:

- 30.1 [Mr AZEVEDO thanked](#) the ITTF staff and the colleagues of the ITTF Executive Board during the last four years, and reflected on the mandate just completed, indicating that achievements in some areas were made. He hoped for his successors, particularly Ms SUNG and Mr CALLE, from the Americas, to continue elevating the ITTF and wished success to the ITTF in the celebrations of the Centenary.

Mr SYMONS thanked Mr AZEVEDO for his contribution.

- 30.2 Mr CALIN provided an update on behalf of the ITTF Events Department regarding the bid procedure for the World Youth Championships 2027 and 2028 and the World Masters Championships 2028. The AGM noted the five phases the bid process will consist of:

Phase 1: Expression of Interest (15 January – 15 March 2026)

Phase 2: Site visit & dialogue (1 April – 31 May 2026)

Phase 3: Finalising bids (1 June – 15 July 2026)

Phase 4: Evaluation of bids (15 July – 15 August 2026)

Phase 5: Host City Selection (September – October 2026)

- 30.3 [Mr Roman MARKOV, delegate of RUS, congratulated](#) the newly elected ITTF officials and addressed the AGM, regarding the principle of non-discrimination and the autonomy of sport. He highlighted recent International Olympic Committee (IOC) recommendations advising international federations to refrain from hosting events in Indonesia following that country's refusal to allow Israeli athletes to compete in international championships. Mr MARKOV recalled the 2010 World Championships in Moscow, noting that the Russian federation successfully implemented solutions to allow athletes from Kosovo to compete, despite a lack of official government recognition, following instructions from then-ITTF President Adham SHARARA. He formally urged the newly elected Executive Board to uphold these IOC principles and ensure that all members of the global table tennis family are permitted to compete in international tournaments without bias or discrimination based on nationality.

- 30.4 [Mr KABBANI intervened for the third time](#), asking about what measures are in place to ensure that the voting is transparent, secure and auditable by the members, and thanking Mr DAINTON for the measures and hardworking, he disagreed in relation to the Secretary General, indicating it is time for refinement, restating that he would be happy to see what measures will happen after this AGM.

This intervention received no response, only an [acknowledgement by the Chair](#).

- 30.5 [Ms Claire BRIEGAL, Chair of Table Tennis England](#), congratulated the newly elected and appointed officials and extended a formal invitation to the global table tennis family for the 2026 World Team Table Tennis Championship Finals in London, scheduled for 28 April to 10 May 2026. She highlighted the success of the recent WTT Star Contender at the Copper Box Arena and reported on a productive inspection visit by President SÖRLING and ITTF staff to key venues, including the OVO Arena, Wembley, and the Ilford Ping hub, where they observed the "Ping for the People" social impact program.

Ms BRIEGAL emphasised that these championships would be a historic milestone, marking 100 years since the city hosted the very first World Championships. She expressed strong confidence that London would host the "best ever" championships and urged all international delegates to apply for their visas promptly to facilitate a smooth entry into the United Kingdom. She concluded by welcoming all nations to "take their seat" at the upcoming centenary event.

- 30.6 [The ITTF President, Ms Petra SÖRLING, addressed the AGM](#) by thanking the global table tennis family for their participation, which allowed the 2025 AGM to conclude in a "calm and forward-looking spirit". She began by acknowledging the 15 November birthday of Honorary President, Thomas WEIKERT, and expressed her sincere gratitude to the former Executive Vice-Presidents for their service, with special thanks to the meeting Chair, Mr Graham SYMONS. She also commended the ITTF Group CEO, Mr Steve DAINTON, the Secretary General, Mr Raul CALIN, and the entire management team for their efforts in delivering the meeting continuation during an unprecedented period.

Reflecting on the state of the sport, the President expressed pride in the community's resilience, noting that events and development programs have continued to grow despite recent challenges.

She warmly congratulated the newly elected Executive Vice-Presidents, the ratified Council members, and the appointed Committee Members, hoping for a professional and fruitful collaboration over the next few years.

Ms SÖRLING acknowledged her re-election as a renewal of the membership's confidence in her program, vowing to translate global success into global impact while fostering a culture of accountability, responsibility, and merit at every level.

Looking toward the future, she emphasised that "standing still is not an option" and that the ITTF Centenary in 2026 would open a vital phase for modernisation and reform. In her concluding remarks, she stated she was deeply honoured to continue serving as President during this crucial time for the sport.

Mr SYMONS thanked Ms SÖRLING for her intervention.

31. Adjournment:

Mr SYMONS thanked all delegates for their constructive participation and indicated that the decisions adopted during the AGM will take effect in accordance with the ITTF statutes and that the Minutes of the AGM will be circulated in due course.

Having no further business, the meeting was adjourned at 21:00 SGT (Singapore time).

To add a new clause under 1.46.1.1. (Appointment of a Chair) as follows:

1.46. AGENDA

1.46.1. The agenda for an AGM shall include:

1.46.1.1. the appointment of a Chair

1.46.1.1.1. In any election year for the positions of ITTF President or membership on the Executive Board, no individual standing as a candidate for any of these positions shall be permitted to preside over the Annual General Meeting (AGM)

Rationale:

- 1. Ensuring Integrity and Impartiality: The goal is to prevent any conflicts of interest, as chairing the meeting could provide an unfair advantage in the election process.*
- 2. Promoting Transparency: Prohibiting nominees from chairing the AGM ensures that the electoral process remains fair and unbiased.*
- 3. Enhancing Credibility: This measure strengthens trust among member associations in the governance of the ITTF.*
- 4. Protecting the Election Process: It creates a more equitable and transparent environment for all candidates.*

PROPOSITION A-02 – PASSED

Proposition A-02

(2/3 majority required)

Proposed by the Continental Federation of Asia (ATTU).

To amend Article 1.60.1.

1.60. COMPOSITION

1.60.1. The Executive Board consists of:

1.60.1.1. the President;

1.60.1.2. 8 Executive Vice-Presidents ~~of which one shall be designated by the President as Deputy President and another one shall be designated to be responsible for finances;~~

Proposed Amended Article:

- 1.5.4.4** The Deputy President and the Vice-President for Finance shall be elected by the General Assembly during its session from among the elected members of the Executive Committee.
- The Deputy President and the Vice-President for Finance shall be elected by a simple majority of the votes cast.
 - The President's right to appoint either of these positions is revoked to ensure independence and transparency in the election process.
 - In the event of a vacancy in either position between two General Assembly meetings, the Executive Committee shall organize an extraordinary election to fill the position until the next General Assembly session.

Rationale:

Ultimate Objective of the Amendment:

- *Enhancing Transparency: Transforming the selection process for the Deputy President and Vice-President for Finance into a democratic process that ensures fairness and clarity.*
- *Strengthening Good Governance: Implementing practices that ensure accountability and balance of power at the highest levels of the ITTF.*
- *Empowering the General Assembly: Granting the General Assembly, as the ITTF's supreme authority, a central role in selecting key leadership positions.*
- *Reducing Individual Influence: Limiting the President's discretionary power over key appointments to safeguard the independence of leadership roles.*
- *Encouraging Competence: Opening the door for competition among candidates and enabling the presentation of clear work programs that align with the ITTF's vision and goals.*

Justifications:

1. *Ensuring Fairness: Transitioning to an electoral system that promotes impartiality and integrity in leadership selection.*
2. *Minimizing Individual Authority: Reducing the influence of the President in making significant appointments.*
3. *Aligning with International Governance Standards: Enhancing trust and transparency in line with global best practices.*
4. *Engaging Stakeholders: Increasing the involvement of the General Assembly in strategic decision-making.*
5. *Securing Continuity: Establishing a clear mechanism for filling vacant positions without disrupting ITTF operations.*

(2/3 majority required)

Proposed by the Continental Federation of Europe (ETTU).

To amend Article 1.60.1.3.

1.60. COMPOSITION

1.60.1. The Executive Board consists of:

1.60.1.3. 2 members from the Athletes' Commission from different genders **and different continents**; and

Rationale:

To ensure diversity and global representation of athletes.

PROPOSITION A-04 – WITHDRAWN

Proposition A-04

(2/3 majority required)

Proposed by World Table Tennis (WTT).

To amend Article 1.60.1.

1.60. COMPOSITION

1.60.1. The Executive Board consists of:

1.60.1.1. the President;

1.60.1.2. 8 Executive Vice-Presidents of which one shall be designated by the President as Deputy President and another one shall be designated to be responsible for finances;

1.60.1.3. 2 members from the Athletes' Commission from different genders; **and**

1.60.1.4. any IOC member connected to Table Tennis; **and**

1.60.1.5. the CEO of World Table Tennis (WTT) as an ex-officio member by a decision of the Executive Board.

Rationale:

As the sole commercial rights entity of the ITTF, which ITTF has entrusted to enhance, promote, professionalise and drive the growth of Table Tennis, it is important that the entity, through its representative, is fully aligned and invested into the coordinated work of the ITTF for the betterment of the sport. This also acknowledges the essential role of WTT in the ITTF's ecosystem while ensuring that its commercial and operational leadership is represented at the governance level, to be able to provide direct input, aiding in better informed decision-making.

PROPOSITION A-05 – DEFEATED

Proposition A-05

(2/3 majority required)

Proposed by the Member Association of Iraq (IRQ).

To add a new clause under 1.71.3 HONORARY PRESIDENT.

~~1.70.3.1. Any past President of the ITTF shall be automatically bestowed the title of “ITTF Honorary President” with a set of privileges decided by the Executive Board from time to time.~~

~~1.70.3.2. This title can be revoked by a Simple Majority vote of the AGM or by a decision of the ITTF Tribunal.~~

1.71.3.1. Any former President of the ITTF may be granted the title of “ITTF Honorary President” for a term of eight years, following a simple majority vote by the AGM. The privileges associated with this title shall be determined by the Executive Board and may be adjusted from time to time.

1.71.3.2. The title of “ITTF Honorary President” may be revoked under any of the following circumstances: A simple majority vote by the AGM, failure to attend the AGM, or a decision by the ITTF Tribunal.

Rationale:

PROPOSITION A-06 – WITHDRAWN

Proposition A-06

(2/3 majority required)

Proposed by World Table Tennis (WTT).

To add Article 1.81. and renumber the subsequent articles.

1.81. BETTING INTEGRITY COMMISSIONER

1.81.1. The Betting Integrity Commissioner shall be appointed by the Executive Board.

1.81.2. The term of office of the Betting Integrity Commissioner shall coincide with that of the Executive Board.

Rationale:

Based on an annual study by Sportradar in 2024, table tennis ranks no.3 in the list of sports involved in match-fixing with a high volume of suspicious matches. Lack of regulation and rise of garage leagues has tarnished the sport's reputation and heavily impacted its commercial value negatively. More focused regulation efforts should be put in place to address the issues arising from illegal betting and corruption in our sport, with a dedicated team focused on this area.

PROPOSITION A-07 – PASSED

Proposition A-07

(2/3 majority required)

Proposed by the Member Association of Uganda (UGA).

To amend Article 1.71.1.

1.71. PERMANENT COMMITTEES

1.71.1. The Equipment Committee, **Marketing Committee**, Nominations Committee, Para Table Tennis Committee, Rules Committee, Sports Science and Medical Committee, Sustainability Committee, Umpires and Referees Committee, and Masters Committee are permanent Committees.

Rationale:

There is nothing more important today to most of our Countries than the need for more development financing and other resources. For many years we have not had a dedicated attention to the marketing efforts of our Sport and indeed most countries are not aware of the overall strategy or plan being used to grow the finances of our Sport. Most countries are even not aware of what they need to do to contribute to the financial growth of the Sport. We have also never had any Marketing Session to plan together how to make our Sport more financially powerful for the benefit of all our Countries.

This Gap needs to be closed by having a permanent Marketing Committee that reports to the AGM on all the above areas aimed at getting more development financing and other resources for all our Countries. All our countries need to also follow this very important aspect closely and to get regular reports on the progress.

Our countries also need to make contributions to this strategy and we all contribute to the growth of the financial welfare of our Sport for our own benefit.

The ITTF Executive Board has tried to rely on the “Business and Development Unit” but this has not working out as well as we had all hoped. With a Constitutionally established Marketing Committee, more attention will be given to this very important aspect of our Sport by AGM authority and it will most likely be handled much better.

PROPOSITION A-08 – PASSED

Proposition A-08

(2/3 majority required)

Proposed by the Continental Federation of Oceania (ITTF-Oceania)

To amend Article 1.79. replacing the Gender & Diversity Commissioner with a new Permanent Committee.

~~1.79. GENDER AND DIVERSITY COMMISSIONER~~

~~1.79.1. The Gender and Diversity Commissioner shall be appointed by the Executive Board.~~

~~1.79.2. One gender and diversity representative who is not from the same continent as the Gender and Diversity Commissioner may be nominated by each Continental Federation and appointed by the Executive Board.~~

~~1.79.3. The term of office of the Gender and Diversity Commissioner and the gender and diversity representatives shall coincide with that of the Executive Board.~~

1.79. GENDER EQUITY DIVERSITY & INCLUSION COMMITTEE

1.79.1. The Gender Equity Diversity & Inclusion Committee shall be composed of at least 6 members, including:

1.79.1.1. one representative from each continent appointed by the ITTF Council;

1.79.1.2. at least one independent individual appointed by the Executive Board, and

1.79.1.3 at least 50% of the Gender Equity Diversity & Inclusion Committee shall be female.

1.79.2. The terms of office of the Gender Equity Diversity & Inclusion Committee shall coincide with that of the Executive Board.

Rationale:

The global sport of table tennis prides itself on being a sport for all, for life. Further growth can be achieved if the sport is more diverse and inclusive. To demonstrate that ITTF is serious about its objectives, it is proposed that the current Gender, Equity, Diversity and Inclusion Taskforce should be disbanded, and, in its place, a new Permanent Committee be established. While the Taskforce has made some initial positive steps, a formal structured Committee with robust Terms of Reference is needed to champion change.

PROPOSITION A-09 – DEFEATED

Proposition A-09

(2/3 majority required)

Proposed by the Member Associations of ALG, BRA, BRN, DJI, ERI, ETH, HUN, INA, IRI, IRQ, JOR, KAZ, KGZ, KUW, LBN, LCA, MDV, MGL, NEP, OMA, PLE, QAT, SOM, SUD, TUN, UAE, UGA, and YEM.

To add a new clause under 1.86.6.

“In the event that the ITTF President is elected from a specific continent, the positions of ITTF Chief Executive Officer (CEO), and Secretary General shall each be occupied by individuals originating from distinct continents. Under no circumstances shall more than one individual holding these three leadership positions be from the same continent.”

Rationale:

- 2. Global Perspective. Leaders from diverse geographical backgrounds can better understand and address the needs and interests of all regions.*

PROPOSITION A-10 – PASSED

Proposition A-10

(2/3 majority required)

Proposed by the ITTF Executive Board.

The expulsion of the Pengurus Pusat Persatuan Tenis Meja Seluruh Indonesia (PPPTMSI) from the ITTF Membership and the recognition as a new ITTF Member Association in Indonesia, the Indonesia Pingpong League.

Rationale:

The sport of table tennis has suffered for over eight years in Indonesia, with repeated reports of internal disputes about its governance, complaints from athletes, associations of athletes, the Indonesia Olympic Committee, and the Indonesia Ministry of Sports.

The ITTF and the ATTU have tried to assist in resolving the problems and concur with the Indonesia Olympic Committee's analysis that the longstanding governance disputes within Indonesian Table Tennis between the different parties remain unresolved, with no indication of a settlement in sight.

- 5. Therefore, the ITTF and the ATTU fully support the Komite Olimpiade Indonesia's position that our sport needs a fresh start in Indonesia, hence, this proposition.*

PROPOSITION A-11 – WITHDRAWN

Proposition A-11

(3/4 majority required)

Proposed by the Equipment Committee.

To amend 2.1.

2.1 THE TABLE

..//..

2.1.4 The playing surface shall be uniformly dark coloured and matt, but with a ~~white~~ side line, 2 cm wide, along each 2.74 m edge and a white an end line, 2 cm wide, along each 1.525 m edge; **these lines shall be of the same colour and clearly different from the colour of the playing surface.**

..//..

2.1.6 For doubles, each court shall be divided into 2 equal half-courts by a ~~white~~ centre line **of the same colour as the side lines**, 3 mm wide, running parallel with the side lines; the centre line shall be regarded as part of each right half-court.

3.2 EQUIPMENT AND PLAYING CONDITIONS

3.2.1 Approved and Authorised Equipment

3.2.1.5 If the lines on the table surface are not white but of another colour, the ball shall be white only.

3.2.1.6 The net tape of the net assembly shall be of the colour of the side lines.

Rationale:

Following the WTT corporate design, the colours of the lines on the table surface and the colours of the net tape should be incorporated into the ITTF Statutes. Furthermore, the Paris 2024 Olympic and Paralympic Games demonstrated that tables with coloured lines can better present the sport. To ensure consistency across the entire ITTF Statutes, the addition of 3.2.1.5 and 3.2.1.6 is presented to the AGM as per 1.38.1.11.

RESOLUTION A-12 – PASSED

Resolution A-12

(simple majority required)

Proposed by the ITTF Executive Board.

To introduce fresh new ITTF Statutes for the next centenary that reflect more accurately the modernisation and advancements of our sport and the world that we live in today and in the future.

Rationale:

The current ITTF Statutes was first introduced in 1926, almost 100 years ago, and relevant to those times. Throughout the years, parts of it have been amended according to needs, although the general framework and regulations remain the same. With the modernisation and advancement of the world today and the development and growth of our sport in recent years, new Statutes that more accurately reflect the world we live in today and in preparation for the future are integral to better promote, represent and continue to grow our sport for future generations.

RESOLUTION A-13 – WITHDRAWN

Resolution A-13

(simple majority required)

Proposed by the Member Association of Türkiye (TUR).

Para table tennis is one of the most universal Para sports in the world. Since its inclusion in the 1960 Rome Paralympic Games, it has been featured in every edition of the Games. Currently, it ranks as the third-largest sport in terms of athlete participation, surpassed only by Athletics and Swimming. To ensure this intense competition continues fairly, the classification system should be updated and strengthened. However, classes should not be merged.
